In July 1994, Final Harvest was running an evening shift to take advantage of the cool weather. One of Anita's co-workers was Michael Williams. After her arrest, Anita tried to send letters to Michael and his sister Joan through Diane Fields, but she turned the letters over to the OSBI (Appendix 36). After Jessie's trial, Anita boasted to Sherry that she had fooled Jessie while working for Final Harvest, because she had an affair with somebody at work behind Jessie's back. Michael Williams most likely is the person with whom Anita was having an affair at the time of the arrests.

M. The July 1994 Arrests.

Six weeks short of three years from the deaths of Judy and Melissa, Anita Cummings gave Jessie the startling news that she had shot and killed Judy. On Sunday, July 24, 1994, Jessie and Anita had driven to Durant, OK, for a major food-shopping trip. On the way back, they got into an argument which resulted in Anita becoming more resolved to leave Jessie.⁷ Anita had always gotten the short end of the stick in this pluralistic marriage, because Sherry dominated and controlled her, and Anita had to share Jessie with an ever increasing pool of women. Jessie's health problems, and the loss of all his teeth that summer, had made him less attractive to her, and she was looking for a man who would give her his undivided attention.

On Wednesday, July 27, 1994, Anita decided to tell Jessie she wanted to leave. That evening, the usual group of people were at the Cummings' house: Chick, Cliff Long, Shirley Cunningham and her kids, Vicki and Orlin Yaws, and Omar and Mandy Bayles. Anita asked Jessie to come to their bedroom with her to talk. Once alone with Jessie, Anita shared with Jessie her intent to leave. She also divulged to him she was the person who had shot and killed his sister Judy. Not thinking beyond the potential consequences of disclosing this information to Jessie, Anita naively thought this admission would cause Jessie to turn her out of the house.

⁷In her pre-trial statements to the police, Anita acknowledged that she had been planning to leave Jessie for several weeks before she went to the police to seek assistance in getting her children from Jessie (Appendix 19, p. 29).

Jessie kept pressing Anita for more information and details. All he was able to elicit from her was:

- Anita had shot and killed Judy during an argument;
- they had kept the body in the cellar until nightfall, and then moved it to the pond;
- Anita had taken Melissa with her and done away with her.

(see Appendix 24 & 7). Despite Jessie's efforts to press Anita for more details, this is the most he could drag out of her. He didn't want her to leave the bedroom until she had told him more.

At one point, Sherry came into the bedroom and discovered that Anita was telling Jessie about the killings. Sherry became upset with Anita and tried to jump her, but Jessie intervened and sent Sherry out of the room. At another point during this conversation, Shirley Cunningham came in the room to let Jessie know that she and the kids were ready to go back to the house in Phillips. Sherry drove them home. At bedtime, Jessie chose to sleep on the couch rather than in the marital bed -- something he had never done before during their marriage.

The next day, Jessie locked up in the travel trailer next to the house all of the guns owned by them, in order to keep the woman from killing each other. Throughout the day Jessie pressed Anita and Sherry for more details. He asked Anita if she would go with him to talk to Coal County Sheriff Bill Ward and tell the Sheriff what she had told Jessie. He also planned to go to Wal-Mart in Atoka and buy another tape recorder in order to get Anita to say on tape what she told him. Jessie kept trying to elicit additional information from Anita and Sherry, and only heard the same minimal details. He also had to keep Anita and Sherry apart, because Sherry was angry with Anita and wanted to beat her up.

That night, Anita left for her evening shift at Final Harvest as usual. Sherry, who knew Eddie Fields and worked for him before, drove along with Anita, which gave the woman an opportunity to discuss what to do next. A major concern for them was Jessie's expressed intent to make Anita tell the Sheriff about her roll in the killings. When they arrived at Final Harvest, Eddie Fields told Sherry he did not have enough work that night to add her to his workforce. Sherry called

home, and Chick came to pick her up.

After Sherry left, Anita approached Eddie Fields for advice on how to leave Jessie and get her two kids out of the house to be with her. In order to get him to help her, she claimed that Jessie had been abusing her and the kids. Eddie eventually brought his wife Diane into the conversation. Suggestions were made about going to women shelters, and phone calls were made to the Atoka Sheriff's Office to obtain assistance in getting the kids out of the house. The Atoka Sheriff's office explained that it was a Coal County matter, since the kids lived in Coal County.

Eddie and Diane both knew Jessie and his household, and probably were skeptical about some of the stories Anita told them about being abused by Jessie. Anita became bolder and escalated the stories she told the Fields -- first insinuating that Jessie controlled her by a secret that they shared, and eventually claiming that Jessie and Sherry had forced her at gun point to shoot Judy (although it was later proven that Jessie was in Oklahoma City when Anita shot Judy and could not have forced Anita to do it at gunpoint). As with her revelations to Jessie, Anita failed to impart any significant information about how Melissa was killed. (Appendix 25 & 26).

Eventually arrangements were made for Anita to go to the Coal County Sheriff's office to obtain their help in getting the children of the Cummings' house. Anita claimed to be afraid that she would be followed there by Jessie, so the Atoka Sheriff's Office provided an escort to the County line, where a Coal County escort took over. Anita arrived at the Coal County Sheriff's office at 3:23 a.m. (Appendix 17). According to handwritten notes of the Deputy on duty, Anita requested assistance in getting her children out of her house because her husband had held her at gun point for 3 ½ hours and threatened to kill her if she left him; nothing was said about the killings (Appendix 17).

Undersheriff Tom Griffin was contacted at 3:30 a.m., the judge contacted at 3:35 a.m. and Assistant D.A. Becky Baird was contacted at 3:40 a.m. Apparently during this time Anita was asked to write out a handwritten statement. In that statement, Anita mentioned:

- the argument with Jessie the Sunday before on the way home from Durant;
- her request to leave the marriage and her claim that Jessie was refusing to let her go;

-her claim that he held a gun to her head Wednesday night for hours, and again Thursday morning.

(Appendix 17). Nothing was said about the killings.

Anita was interviewed by Undersheriff Griffin at 5:00 am (OR 2). He apparently explained to Anita the kind of information needed to get an order to remove her kids from Jessie's house. During the course of that discussion, Anita verbally told Griffin she had murdered Judy Mayo, and Sherry and Jessie were involved in both homicides (*id.*). At 5:30 am, Anita's request to talk to Sheriff Ward was relayed through the dispatcher (Appendix 17). At 5:45 am, Anita was questioned by Sheriff Ward and Undersheriff Griffin. In the tape-recorded portion of that interrogation, Anita confessed to killing Judy (Appendix 17). She told them that: Jessie told "them" to kill Judy or he would kill them; she shot Judy on the couch inside their house; she and Sherry put Judy's body in the cellar, and then Anita went to work; when Jessie got back from Oklahoma City, he and Sherry moved Judy; when Jessie and Sherry came back, they took Melissa and left again; when they returned without Melissa, Jessie got rid of the couch; she didn't know what had happened to the gun; that Jessie knows how to play head games to get people to do what he wants (*id.*). No claims were made about Melissa being raped.

At 6:30 am Anita was placed under arrest. According to the Sheriff's Office booking sheet, the only sign of an injury on her body was a bruise on her right wrist (Appendix 17). The OSBI was contacted about these developments. At some point Judge Branam signed Orders, finding Probable Cause to detain Anita, Sherry and Jessie (Appendix 54). No record was made of that Probable Cause hearing (Appendix 7). Nor is there any record as to whether the Judge's probable cause finding was based on an affidavit or verbal testimony.

Sheriff's Deputies went out to the Cummings' house in Lehigh early that morning and removed six year old Robbie and one year old Ashley from the home. By way of explanation, Sherry and Jessie were told that Anita had had a nervous breakdown. When they called the Sheriff's Office to obtain more information, they were told to come in to see the Sheriff at 8:00 a.m.

En route to the Sheriff's office, they stopped at the house in Phillips where they dropped off

7 year old Debbie. When they arrived at the Sheriff's Office, Jessie was immediately wrestled to the ground, cuffed and arrested for the murders of Judy and Melissa. He did not resist. Then Sherry was arrested in the same way. They were placed in separate cells. A short time later, Sherry was transported to the Pittsburg County Sheriff's Office.

Around 10:00 am, Jessie was transported to the Atoka County Sheriff's Office by Atoka County Sheriff Gary McCool and his deputy Junior Head. En route, Jessie was informed that Anita had implicated him in the murders, and that they had strong evidence against him. Nothing was mentioned about Melissa allegedly being raped, although they did press Jessie for an explanation as to how he could get so many woman to be interested in him.

Both Eddie Fields and Diane Fields were interviewed the day of the arrests. In addition, each of them also wrote out a statement of what Anita had told them the night before. Diane Fields reported, in both the interview and her handwritten statement (Appendix 25), that Anita had been working for them for four months, and that she came to work with Sherry at 7:00 pm the night before. Because they did not have a job for Sherry, she left. After Sherry left, Anita told her and Eddie about her attempt to leave Jessie and his holding her at gunpoint for several hours on Sunday, and holding her against her will for a couple of days. Anita also told Diane stories about Jessie mentally, physically and sexually abusing her and her son. They suggested to Anita that she go to a crisis shelter. Anita eventually told them she could not leave Jessie because they were tied by a secret, which was that: Anita had shot and killed Judy Mayo, Sherry and Anita put the body in the basement, Anita left for work, and when she returned from work at 11:00 p.m. Melissa and Judy's body was gone, and she did not know who killed Melissa. Nothing was said about Melissa being raped, Jessie forcing Anita to kill Judy, or Jessie participating in moving Judy's body or Melissa's death (*id.*).

Eddie Fields reported during his interview and in his handwritten statement (Appendix 26) that he spoke with Sherry and Anita when they came to work the night of July 27. Anita spoke openly in front of Sherry about a big argument that Anita had with Jessie. After Sherry left, Anita ~~because~~ nervous and upset, and told him that Jessie had been abusing and threatening her and the ^{BECAME}

kids. He counseled her to go to a safe house, and phone calls were made. After Anita told his wife about killing Judy, she told him about it, too. She told him she killed Judy out of fear for her life, and implied that both Jessie and Sherry stood by her with a gun, making her kill Judy to prove her loyalty. Anita claimed Jessie then told her to take care of Melissa, too, but Anita got sick and refused. Anita and Sherry put Judy's body in the basement and covered it with a blanket. Anita then left for work and, when she got home, Judy's body and Melissa were gone. (*Id.*). Again, nothing was said about Melissa being raped, or Jessie being involved in moving Judy's body or taking Melissa away.

Anita was questioned throughout the day. Other than the statement taped at 5:45 am on Friday, July 29, 1994 (Appendix 18), the only other taped-recorded statement that has been disclosed to the defense was made the next day at 4:30 pm (Appendix 19) [herein the 7/30/94 Statement]. In that lengthy statement, reference is made to Anita having talked with Sheriff Ward and having told him a "bunch of the stuff" that Jessie has done. For the first time, Anita embellishes her account of the murders with a claim that Jessie raped Melissa before taking her away that night (*id.* p 3). In response, Ward says Anita had not told him this before (*id.*). Anita gives no details about the alleged rape. When she embellishes on this claim at the Preliminary Hearings and at trial, her account is not corroborated by Sherry, nor is her account credible.

In her 7/30/94 Statement, Anita mentions that Melissa may have been molested as a baby by her older brothers, Henry and James Moody (*id.* p.23). As noted above, they apparently molested four other siblings, who are the ones taken from Judy's custody in California.

In the 7/30/94 Statement, Anita gives the impression that Sherry is the one who orchestrated the killings. Anything that Anita admits to doing, she claims to have done so under Sherry's domination and control. This includes Sherry forcing Anita to shoot Judy. Anita claims that she told Sherry on the back porch that she did not want anything to do with anything, but Sherry told her she had to do it. (*Id.* p. 3). Anita expands on this theme, that Sherry was forcing Anita to do things that day, under oath at the Preliminary Hearings and at trial. The problem is that both wives would claim that Jessie secretly had ordered Anita that morning to kill Judy, and that Sherry knew nothing about

it until right after the actual shooting (*see, e.g.*, PH-I 92; PH-II 82; T. 520). Sherry knowing nothing about Anita shooting Judy before it happened is inconsistent with Anita's claim that Sherry pushed the gun into Anita's hand and forced Anita to kill Judy and then help clean up afterwards.

In the 7/30/94 Statement, Anita claims that Melissa was sent to the outhouse to go to the bathroom right after Judy was killed (*id.* p. 5), which is a claim that she later abandons. After having opportunities to confer with Sherry in jail, Anita changes her story to conform to Sherry's version, by saying they took the kids into the bedroom, covering their eyes with their hand, although Anita has Sherry taking Melissa in (T. 734), and Sherry has Anita doing that (T. 523-4 & 565).

Another major inconsistency with Anita's later testimony is her assertion in the 7/30/94 Statement that Jessie held a gun on her and Sherry to make them watch him have sex with Melissa (Appendix 19, p. 22). Anita later abandons this claim all together. Sherry's versions contradicts Anita about there being sex or their watching it.

In the 7/30/94 Statement, Anita gives few details about how and when Melissa disappeared. She does say, however, that Melissa was not scared when she left the Cummings' house (*id.* p. 31). Anita also reports a belief that Jessie made Sherry kill Melissa (*id.* p. 34).

In her 7/30/94 Statement, Anita also complains about Jessie being abusive. Her list of grievances includes his not even letting her smoke (*id.* p. 13), which is a reference to Jessie's prohibiting anyone from smoking inside the house after baby Ashley was born in 1993, because Ashley was allergic to smoke. During this interrogation, a suggestion is implanted to Anita that Jessie has used "mental control" over her (*id.* p. 21), which Anita will latch onto and develop into a theme in her subsequent testimony.

Anita also complains about being told frequently during questioning that Judy's pickup was not at the Cummings' house that night (*id.* p. 26). Anita most likely was told that because two people questioned shortly after the offense in 1991 reported stopping by the Cummings' house the evening of the offense and finding nobody home and Judy's truck not there (Appendix 33 & 35). That materially impeaches the women's claims that Judy's body and pickup were not removed from the Cummings' house until after midnight that night.

Anita also emphatically states that it is a "lie" that Jessie had loaned his .38 gun to Judy a few days before she was killed (*id.* p. 28). However, during the police investigation of this case, several people reported this (*see, e.g.*, Appendix 24 & 42), and Sherry more recently confirmed to Jessie's counsel that Judy had indeed borrowed the .38 from Jessie (Appendix 7).

At the conclusion of that tape-recorded session, Anita signs a consent to search the house in Lehigh, and she is taken there for that purpose. Among the items seized during that search was a photo album containing photos of Jessie, Anita, Sherry, and various other adults in sexually explicit poses. Two rolls of film were also seized and developed. None of that evidence was produced with the OSBI Prosecutorial, and that evidence is the subject of the pending Motion to View Evidence in the Possession of the OSBI Relevant to Innocence filed with this Court on February 2, 1998.

The day of the arrests, Sherry refused to talk with the police. Around 4:00 pm that afternoon, Jessie was taken from his jail cell in Atoka up to the District Attorney's office in the Atoka County Courthouse. There, he was questioned by OSBI Agent Dale Birchfield and Chris Dill, and Atoka Sheriff Deputy Junior Head (Appendix 23). Jessie was told that Anita and Sherry had implicated him in both killings, and that the woman were saying that Jessie had raped Melissa. This was not true. The first any claim was made in that regard was the next day during Anita's 7/30/94 Statement (Appendix 19). Jessie denied any knowledge or involvement in the offense.

Jessie's main concern was the three children, and who would watch them while Jessie, Anita and Sherry were in jail. He was told the children were in DHS custody for the time being. Jessie expressed concern the children might be placed with Sherry's mother, indicating his fear they might be molested there. Jessie was asked to take a polygraph, and he agreed to do so reluctantly, explaining to them he did not believe they were accurate. Towards the end of this interrogation, Agent Birchfield asked to talk to Jessie alone. While alone with Jessie, Birchfield indicated that Sherry could be released from jail and could take care of the kids if he could clear her of any involvement.

The next morning, Saturday July 30, 1994, Jessie was taken to Sheriff McCool's office and questioned by OSBI agents Chuck Jeffries and David Cathey, beginning around 9:30 a.m. (Appendix

23). Jessie again denied any involvement. Then he was transported to the South Eastern Regional Office of the OSBI located in Antlers, OK, where that morning he was given three polygraph tests. Throughout the morning, Jessie kept asking about the children and who would care for them. He was told DHS had custody of them, but they might be given to Sherry's mom, because she was the only relative living in Oklahoma.

The polygraph tests were administered by OSBI agent Jeffries. Also present in the room were agents Dill and Cathey. After each test, Jessie was told he had not passed the test. Between the second and third tests, an excerpt was played from Anita's tape-recorded confession made the day before. At this point Jessie decided to claim he was the one who moved Judy's body with Anita, naively thinking that would clear Sherry of any involvement and result in her being released from jail, which would allow her to have the children.

After the third polygraph test, a tape-recorded interrogation of Jessie was made late that morning. This was done in the early afternoon in the same room where the polygraphs had been administered with the same three agents present. In that taped-statement [herein the "Fake Confession"], Jessie tries to make it look like he and Anita moved Judy's body and that Sherry had no involvement. After Jessie learned at his August 1, 1994 arraignment Sherry also was being charged with murder and kept in jail, Jessie contacted agent Dale Birchfield and informed him the confession was false. The fake confession was admitted at trial (Exh. 27, T. 671, reproduced in Appendix 24), but jurors were not aware Jessie had recanted it.

There are several indicators in the Fake Confession that Jessie was merely pretending to know about the disposal of Judy's body. First, the interrogators pressed him to produce the gun used to shoot Judy, explaining that producing the gun would not incriminate him anymore than his admission to moving the body (Appendix 24, p. 97-8). Since there was no question that Anita shot Judy while Jessie was in Oklahoma City, his producing the gun would not affect him. Anita's and Sherry's versions of the offenses is that Jessie was the one who disposed of the gun, and that he did so the night of the offense while moving Judy's body. Nonetheless, Jessie cannot tell them where the gun is, because he does not know. If Jessie had moved Judy's body and disposed of the gun, he

would have told the interrogators where it was located.

A second indicator that the Fake Confession was given in order to help get Sherry released from jail is Jessie's reporting that Anita was the person who helped him moved Judy's body. At the Preliminary Hearing and at trial, the women testify under oath that it was Sherry who helped move the body. They needed to implicate Jessie in moving the body, because they were blaming him for forcing Anita to shoot Judy. However, they made Jessie an accessory after the fact with Sherry, not Anita, who is the person Jessie named.

A third indicator the Fake Confession was made up by Jessie is his lack of knowledge of any details, and his grabbing onto any suggestions about the details supplied to him by the interrogators. All Jessie knew about the moving of Judy's body were the few details supplied to him by Anita and what police had told him in 1991 about the crime scene and Judy's autopsy. Anita had told Jessie that she and Judy had some kind of argument (Appendix 17 [statement dated 12/2/94]), Anita shot Judy, Sherry and Anita put the body in the cellar until nightfall and then moved it to the pond, and that Anita took Melissa and did away with her. In response to questions about other details, Jessie has to repeatedly say he does not know or does not remember.

For example, the police ask him how he moved Judy's body, and he cannot give any details. Finally, when Agent Jeffries tells Jessie it would have been easier to carry the body in a blanket, Jessie says: "I would imagine. *** Yeah I did. I used the blanket, yeah." (*id.* p. 94). In response to another leading question, he adopts that version suggested to him by the interrogator:

Agent Dill: And you, so you used that blanket to draw her?

Jessie: Yeah.

(*id.* p. 107). However, that is not consistent with the women's trial testimony in which Sherry claims that Jessie tied Judy up with a rope to move her into the truck (T. 530). The point is, Jessie simply does not know how the body was loaded into the truck because he was not involved in moving the body, and merely was guessing a blanket was used, because the OSBI agents made that suggestion to him.

Another example of Jessie, who has borderline retarded intelligence (Appendix 5), adopting facts from the agents' leading questions is the following exchange:

Agent Dill: [You] took [Judy's body] out the passenger side [of her pickup]?
Jessie: Um huh.
Agent Dill: Okay, was she leaning up against the door?
Jessie: Yeah.
Agent Dill: She was just kinda slumped over there against the door.
Jessie: Um huh.

* * *

Agent Dill: She probably just fell out of the pickup at that point.
Jessie: More or less.

(*id.* p. 102 & 103).

Similarly, Jessie does not know if Judy was dressed in clothing or not, what wounds were on Judy's body, what happened to the couch Judy was sitting on when shot, what was thrown in the lake when the body was dumped in the pond, or the location of the gun that Anita used to kill Judy.

Jessie incorrectly reports the pickup had been parked right at the edge of the pond, making it easy to roll the body into the water (*id.* p. 96) when the tire track marks found by the OSBI are farther away. He also incorrectly reports the body was left on the edge of the pond, half in and half out (*id.* p. 105) when the photos of the body clearly show it was well into the water (Exhibit 3E, T. 394).

Another indicator Jessie falsely implicated himself in moving Judy's body is that his motivation to lie had a basis in fact. Jessie was fearful in particular that Debbie, who was six years old, and Ashley, who was 12 months old, would be placed with Lahoma Yaws, Sherry's mother. Lahoma was living with David Potter, who had his parental rights to his daughter terminated for abusing her as a young child, and Jessie knew this. Moreover, Lahoma's youngest daughter, had told the authorities in Arkansas in 1991, that David was sexually molesting her, and Jessie knew this, although both David and Lahoma denied it. In addition, David has a brother named Patrick Potter, who was married to one of Lahoma's daughters, and he spent a lot of time at Lahoma's house. Patrick had been accused of molesting his wife's children. He is currently serving a sentence for Statutory Sodomy in the Second Degree in Missouri, having admitted to molesting Lahoma's

granddaughter and pleading guilty to that charge. Jessie also was aware that Lahoma Yaws' sons had been molesting her youngest daughter from a young age (see Appendix 19, p. 2), and her sons were still living at home and/or stayed at her house a lot.

After securing the taped-recorded statement from Jessie, he was transported back to the Atoka Sheriff's Office and placed in a cell. He was not served a noon meal at either the OSBI office in Antlers or in the Atoka jail.

At 4:30 pm that same day (Saturday, July 30, 1994), Anita's tape recorded statement was taken, which is discussed above. At 7:05 p.m., Agents Jeffries and Dill interrogated Sherry. They told her that both Anita and Jessie had implicated her in the offenses. To convince her of that, they played excerpts from Anita's and Jessie's taped statements. Sherry decided to back-up Anita's version, but Sherry also was left to doing some guess work, because she did not know exactly what Anita has been telling the police.

In her tape-recorded statement taken that night (Appendix 20), Sherry claims that Jessie ordered her to kill Judy the night before he went to Oklahoma City with his father, but that she refused. She makes the mysterious and totally false claim that the next morning she took Judy looking at houses to rent. According to Sherry, Anita shot Judy that afternoon and Sherry had nothing to do with telling her to do that or handing her the gun. In Sherry's version, Anita alone put all three kids, including Melissa, into the bedroom while they cleaned up. They put Judy's body in the cellar because Jerry Walker would be coming by to check on animals he kept on their land. She and Anita had sufficient time to agree to accuse Jessie of helping Sherry to dispose of the body (instead of naming the actual third party who was recruited to help with that project), so she says all three of them put Judy's body on the floorboard of her pickup (not on the seat as the police got Jessie to say). Sherry also stated that, when they got back from disposing of the body, Melissa was immediately taken away. She states Melissa did not become scared until arriving at the bridge near where her body was later found. Sherry also states Jessie never raped Melissa, nor Sherry's younger sister, Lahoma Yaws II. Sherry states that Melissa had clothes on when taken away, and cannot explain why her clothing was never recovered.

Inconsistencies between Anita's taped confession and Sherry's taped confession, given hours apart, include the following:

Anita's version

Sherry gave Anita the gun to kill Judy.

Sherry made Melissa go to bathroom in the outhouse.

Sherry cleaned up the floor with bleach and ammonia.

Sherry cleaned up the blood off the couch.

Judy's body was shoved into the water at the bottom of the cellar.

Melissa was raped at their house before being taken away.

Anita & Sherry forced to watch the alleged rape of Melissa.

Anita doesn't know what happened to the gun she used to shoot Judy.

Melissa looked a little scared when she left our house.

Sherry covered Judy's body with a blanket.

Sherry and Jessie loaded Judy's body into Judy's pickup.

Jessie also raped 14 year old Lahoma Yaws II.

Jessie got rid of the couch.

Sherry's version

Anita told Sherry that she wanted the gun, and Sherry told her that she didn't have it.

Anita put all of the kids into the bedroom.

Sherry cleaned up the floor with just dish soap and water.

Anita washed the blood off the couch cushions.

Judy's body was sitting on the steps, not on the floor of the cellar.
