## INTERVIEW OF PHILIP MARKOFF

DET. HARRIS: All right. For the record today's date is April 20, the year 2009. The time is 2:45 p.m., the speaker Detective Dennis Harris of the Homicide Unit, and also present, Detective Robert Kenney. The young man being interviewed here this afternoon is Mr. Philip -- would you pronounce and spell your last name, please?

MR. MARKOFF: Markoff, M-A-R-K-O-F-F.

## BY DET. HARRIS:

And with that, also, Philip, I'm going to produce a -- just you've agreed to go on tape from the outset, so therefore, there's no need to fill out that form, but now I'm going to produce a Boston Police Department Miranda warning sheet and advise you of your rights.

All right. Would you spell your first name, please?

- A P-H-I-L-I-P.
- Q One L?
- A Yeah.
- Q And spell your last name?
- A = M-A-R-K-O-F-F.

- Q Double F?
- A Yeah.
- Q Markoff. And what's your address, please?
- A Do you want my local address?
- O Yes.
- A 8 Highpoint Circle.
- Q 8 Highpoint --
- A Circle, Apartment 301.
- O And where is that?
- A Quincy.
- Q And today's date is 4/20/09, and the time is 2:46 p.m.

All right. Philip, before we ask you any questions you must understand your rights, okay. You have the right to remain silent. Do you understand that?

You have to respond so that the tape picks it up.

- A Yes, I understand.
- Q Would you do me a favor? Would you place your initials in that space there?
- A [Pause].
- Q You can hang onto the pen there for a second.

Anything you say can and use -- can be

used against you in a court of law or other 1 proceedings. Do you understand that? 2 Yeah. 3 A Would you put your initials there, please? [Pause]. 5 A You have the right to talk to a lawyer for 6 advice before we ask you any questions and to 7 have him or her with you during questioning. Do 8 you understand that? 9 Yeah. 10 Place your initials there, please. 11 [Pause]. 12 A If you cannot afford a lawyer and you want one, 13 Q a lawyer will be provided for you by the 14 Commonwealth without cost to you. Do you 15 understand that? 16 Yeah. 17 A Put your initials right there. 18 [Pause]. 19 A If you decide to answer questions now without a 20 lawyer present, you will still have the right to 21 stop answering at any time until you talk to a 22 lawyer. Do you understand that, sir? 23 Yeah. A 24

Place your initials in that space. 1 This next, let me see it for a second. 2 I, there's a blank space, have read and 3 understand the above rights as explained to you 4 by me, and I will print my name, Detective 5 Harris, and I am willing to make a statement at 6 this time without a lawyer being present. 7 Would you like to speak to us now 8 relative to some questions we have to ask you? 9 Well, it depends what they're about. Maybe I 10 should speak to a lawyer. 11 Well, it's up to yourself, and it's a decision 12 Q you have to make. 13 Well, what's this about? 14 A Well, it's about a series of incidents that have 15 gone on, and we just have some questions. 16 you're well aware of, there's been some reports 17 of some robberies and a homicide, and we've been 18 following a ton of leads as a result of that 19 stuff, and you're a person of interest at this 20 point, and we'd like to speak to you relative to 21 that. 22 Okay. Maybe -- can you get me a lawyer, though? A 23

Can I get you a lawyer?

Q

Yeah. A 1 You have a right to get your own lawyer 3 yourself. Well, I don't -- I don't know. I don't know A 4 where to get a lawyer from. 5 I mean, is that your decision, that you'd rather 6 have a lawyer than to speak with me? 7 I mean, yeah. I don't really know what this is A 8 about, but I probably should. I don't want to 9 say something. 10 It's up to yourself. Is that your request that 11 Q you want a lawyer? 12 I mean, can you get me one? 13 A Well, would you -- just so we understand, to 14 0 understand what's going on. Would you like to 15 have an attorney here today and then continue 16 some questioning, or would you like not to speak 17 at all and get an attorney, because, I mean, you 18 can make a phone call. You can try to have an 19 attorney here and you can go through the 20 proceedings with an attorney present, if that's 21 vour wish. 22 I'd feel more comfortable with an attorney A 23

present, if you could provide me with somebody.

Well, one of your next rights is you have a 1 right to make a phone call. We'll let you make 2 a phone call, and if you want to try to find an 3 attorney and have an attorney respond here. 4 No. You can just have someone here who does 5 A this. 6 We have an attorney that does this? 7 Or, you know, you know what I'm trying to say? 8 I do know what you're trying to say. You want 9 to consult with an attorney before we move 10 forward, is that correct? 11 A Sure. 12 All right. 13 Q DET. KENNEY: Detective Kenney for the 14 record. 15 BY DET. KENNEY: 16 Just so that it's clear. You're asking us to 17 try to provide you an attorney. You don't have 18 an attorney --19 Yeah, I don't have a lawyer. I don't know where A 20 to get a lawyer. 21 Okay. And you absolutely don't want to talk to Q 22 us unless you have an attorney before you talk 23 to us, because the thing of it is, I'm going to 24

be very frank with you. I'm sure you have some 1 idea of what we're looking at here, right? 2 have some idea of what we're talking about? 3 Not really. 4 A Well, you live in the area and you've been 5 watching the news. 6 7 A I don't really watch the news. 8 Do you read the newspapers? 9 A No. Not at all? 10 No. People my age don't really watch. 11 A So you don't watch the news, all right. 12 0 Well, the detective talked about it 13 briefly, that there's a number of incidents that 14 have happened in the area. Your physical 15 description and that you're a white male with 16 light-colored hair has triggered our interest in 17 you to some -- a certain extent, but as you can 18 imagine, there's about probably 80,000 other 19 people that are about your height, about your 20 facial features, about your hair color. 21 Yeah. 22 A You're a person of interest because of these 0 23

things and some other things. We would like to

talk to you about that, but we're not going to 1 talk to you if you insist on having an attorney. 2 What are the other things? 3 Well, until we get through this format, we can't 4 talk to you about anything. 5 Okay, well --6 But we have to -- we have to make sure that your 7 rights -- I mean, we're going to be zealous in 8 making sure that your rights are preserved. 9 All right. 10 That is our obligation to the law and our 11 obligation to you. 12 So I would like -- I would like, can you provide 13 A me with an attorney then? 14 BY DET. HARRIS: 15 We're not going to provide you an attorney. 16 We'll make -- we'll allow you to make a phone 17 call and you can inquire, okay. 18 It says you'll provide me with one. 19 A Well, that's -- that's the process, sir, that 20 says there. Like, if, in fact, you ended up in 21 the court --22 DET. KENNEY: If you were indigent. 23 And the courts found you indigent, then they 24 Q

would provide you an attorney. That's in a 1 different proceeding. This right now, you're, 2 like, number one, you're not under arrest, 3 correct? 4 But you said I could have a lawyer for this. 5 Well, the form is you have a right to an 6 attorney, okay. We don't actually give people 7 attorneys. You can hire an attorney to move 8 forward or at some point, if you were 9 arrested --10 I don't think I can afford an attorney. 11 Well, I mean, that's -- you know, I mean, that's 0 12 -- phone calls can be made to a company, the 13 public defender's office, and maybe they can 14 make one available to you. However, you're not 15 the deciding factor of whether or not you can 16 afford an attorney. The court's are. But the 17 bottom line as far as this interview goes, 18 Philip, so we're clear, is you have a right to 19 have an attorney with you while you're being 20 questioned if you so choose, okay. 21 Okay. 22 A Or you can shut down, you don't want to speak to 0 23 us because you want to take -- take advantage of 24

one of your rights and get an attorney, and you can postpone this until that time.

The way that works, if we're going to provide you with an attorney, we being the Commonwealth of Massachusetts, that means that there's a process in place if you were arrested, brought before a court, and you tell the court that, hey, look at, I can't afford an attorney and I want one, and it's at that point, they'll either deem you indigent where you absolutely because of the information you provide them cannot afford one and they'll provide you with a public defender. However, if they find that you have the means, either with family or other areas to afford an attorney, then they'll tell you to get an attorney before the next court date, to hire an attorney yourself. But right now, you can, you know, we can see what's going on. If you want an attorney, that means we shut down, okay.

- A But I can stop at any time, right?
- Q Well, that's another one of your rights. If you understand that as we read, you can proceed.

  You can talk to us. It's your right. You have

to waive it, though. You have to tell me that, 1 hey, look at, I understand my rights fully and 2 I'm willing to talk to you, and I can stop at 3 any time, also. That's one of your rights. So do you want me to fill this out, the rest of 5 it? 6 Yeah, fill that out. And is that your 7 understanding, that you're willing to talk to me 8 or you want to waive that? 9 Well, you said I can stop at any time. 10 You can stop at any time. 11 Well, I just want to hear what's going on from 12 A you, so we can start. 13 Okay. Just so we're clear though, we're going 14 on the record. You asked for an attorney. 15 Detective Kenney, just in terms of filling 16 out --17 From what you were saying, explaining it to me, 18 A I thought, like, you would provide me with one. 19 Oh, yeah. We just don't give people attorneys. 20 Q Well, that's what I thought, like, would happen A 21 so. I may have misunderstood. 22 So the fact that you inquired about your 0 23 interpretation of that right, was that I had an 24

attorney waiting outside and I'd let you speak 1 to an attorney or something along those lines? 2 Well, that's what I thought. That was my 3 understanding. Okay. Your thoughts now is that you understand 5 what I've explained to you. 6 I understand if I want an attorney now, I have 7 A to get one myself. 8 Right. Yes, or make a phone call and, you know, 9 have one made available to you. We're not going 10 to give you one. 11 I wouldn't really know who to call to be an 12 A attorney. 13 But, I mean, that's what phone calls and that's 14 what -- there is advice out there for you to 15 follow up on that. But before we move forward, 16 Philip, you're clear on the fact that as you sit 17 here, you're willing to speak and you know that 18 right where you can shut down at any particular 19 time? 20 Yeah, I know -- I know I can shut down at any A 21 time. 22 Okay. So you're aware of that, and you're aware 0 23 of the way it works? 24

1 A I just want to hear what's going on, so you can start.

- Q But rather than for you just to find out what this is all about, you're clear about your rights?
- 6 A I know my rights.
- 7 Q You know your rights. Have you ever been advised of your rights in the past?
- 9 A No.

As I alluded to early on about 6 that, there's been a lot of stuff gone on, and 7 as a result of that stuff, there's been hundreds 8 of tips coming in here, and if you haven't read 9 the paper, you really don't have a clue as to 10 what we're talking about? 11 No. I really don't read the paper or watch the A 12 news. 13 So in the last week or two, you haven't heard 14 anything about some stuff that's been going on 15 in and around Boston regarding Craigslist? 16 No, I really don't watch the news. 17 A Okay. Well, just let me give you a brief 18 0 synopsis of what we're doing then, okay. 19 A Okay. 20 There's been a series of incidents, robberies of 21 0 young girls in and around the Boston area. 22 A Okay. 23

And as a result with that, the Boston Police

Q

Department and other agencies have asked the public for some help. They actually printed some surveillance photographs of people that they thought might be involved in this case, and as a result of that, asking the press for some help, it generated an awful lot of phone calls. People are saying, gees, I think the guy who lives next door to me might be a person of interest.

A Mm-hmm.

- Somebody else is calling, you know, I work in such and such a place, and, you know, this dude who comes in here every day, you know what it is. You know what I'm saying?
- A Mm-hmm.
- So we are following up each and every lead that comes across the phones. I can tell you as I sit here in my limited capacity, there's a photograph in one of the surveillance photographs or a couple of the surveillance photographs that's a strong likeness and image to yourself, Philip.
- A Okay.
- Q One of the reasons why you're here. So I was

I'm finishing up my second year. 5 Your second year, all right. And have you lived 6 at that Quincy address since then? 7 Since I started. No, I lived in South Boston, 8 A and then I moved to Quincy. 9 How does it feel to be wrapped up in this stuff? 10 I mean, this is -- is this your first time being 11 involved with this? And I know you said you 12 worked at the youth court. What do you think 13 about being dragged in here on a --14 I don't know. I was trying to figure out what 15 A was going on. 16 Okay. And as you know, I mean, if you have some 17 familiarization with the courts, especially in 18 something, it's an investigation. You know the 19 unit you're in now. Did you see the sign when 20 you walked in the door? 21 No. A 22 It says the Homicide Unit, and I introduced 23 myself as a homicide detective. 24

A Okay.

So that tells you at least something, something that we're talking some serious stuff here, okay, and following tips.

And ever since, going back to the OJ case, the sensationalism of the OJ case, which causes the public to respond in following leads, we're kind of like, you know, we're at, you know, a point where people call stuff in and we follow up on it regardless of what it is, because in the courts, people will say, well, you know, 45 phone calls come in; you followed up one or two of them. Why didn't you do them all?

And I can tell you is that there's a strong likeliness of one of the photographs in the surveillance photos such as yourself. So I was just maybe hoping that you had some explanation. Say, if I gave you a date of a couple of weeks ago, if you were to tell me there's a reason why you were there and the person in the photograph was deemed to be you, then maybe you'd have a logical explanation for being in that area, but you don't seem to call

to mind --1 Well, I went out to eat at the Cheesecake 2 Factory in the last -- maybe a couple weeks ago. 3 Which is right there? 4 Yeah. 5 A Do you remember the day that might have been or 6 7 the --I don't remember the date. 8 A And I understand, because sometimes I don't even 9 know that, you know, what day of the week it is, 10 what date it is now. But as far as, you know, 11 going out to a restaurant, people might say, 12 well, I like it there on Wednesday nights 13 because they have a good special, or do you 14 happen to remember --15 No, I don't go out to eat much. I went out A 16 with Megan and a couple friends, and we go 17 shopping there sometimes at the Prudential 18 Center. 19 All right. And when you say, was that a couple 20 0 of weeks ago? 21 I don't remember when it was. 22 A You don't remember the day or anything like -- I 0 23 can imagine a BU student --24

And I can tell you this. And as I've said homicide a couple of times, clearly, you must think that it involves a murder. I've also mentioned the word robbery, and it involves robbery. I mean, those are memories that we'd always have, but to you, I mean, you're going to Foxwoods all the time. Maybe that's the explanation for why you can't call it to mind for not being there.

But then again, if you're willing to work with me and try to -- try to, you know, figure out if you were there, that might explain why we're sitting here today. But if you sit

there and you just have no -- absolutely, 1 positively no memory of being there, it just --2 it just doesn't help things, you know. 3 Well, I said I have no specific memory. Or you could be as we said, just simply that guy passing through. But is it more than a

other than just maybe I passed through? Do you have a thing? Do you hook up with girls that you meet and you just don't want Megan to know about it? Which is perfectly understandable.

Over the years a lot of times, a guy's They want to tell a story, but sitting there. they don't want to jeopardize relationships. They don't want to ruin an engagement. They don't want to end up in divorce court because they have these things for, you know, they have a girlfriend on the side or something. So that may prevent them from being completely honest, and something like that, that's like a barrier in this business. If it's that simple and that's what throws me off, you know, then trust me, the thing to do is just to be honest and throw it out there and explain why this is going Explain why you're sitting here in the Homicide Unit, you know, at 3:00 o'clock in the afternoon.

There's an explanation for everything, you know. Things happen for a reason, Philip. We can't have back what happened, but we can make it right. And how do we make it right?

I didn't do those things. is what actually happened. This is my story. I'm not a stupid little shit. I know what happened, and I know why it happened, and I can make it right by just being honest.

That honesty is the key to, you know, just move forward, and it opens up all those different doors when you're honest with yourself, and it actually -- the honesty is what explains our behavior. Without honesty,

one-sided stories can be pretty ugly, can be real ugly, because all we have is the evidence at the scene, and that scene can be ugly and can speak to -- it can speak to ugliness without this answer over here. Do you follow me?

Again, you're just nodding. The tape doesn't pick that up. I'm sorry.

It's not easy, Philip, and things
happen, stuff happens, but we can make it right.

Fall back to when we're, you know, brought up.

Little lies turn into big lies and big lies
turns into, you know, big bags of shit, so to
speak, you know. But if we step up and speak
from the heart, hey, okay, listen, nobody ever
meant for things to go the way they went, but
this is what happened.

Maybe -- maybe, maybe it was an accident. Maybe he was -- maybe you were provoked or maybe, you know, things -- things got ugly and you were a victim here at some point, you know, but who knows, unless you speak up, Philip. Who knows?
