AT APPROXIMATELY 23:55 HRS, SGTS BLOYD AND GAFFORD WERE IN THE HOMICIDE DIVISION WHEN LT.NEELY ASSIGNED THEM TO MAKE A SCENE AT 2400 S.KIRKWOOD. HE INFORMED SGTS THAT THERE WERE TWO COMPLS. ONE WAS A 3 YEAR BOY WHO WAS DEAD AT THE SCENE AND A YOUNG WOMAN WHO WAS IN SERIOUS CONDITION. SGTS THEN PROCEEDED TO THAT LOCATION.

WHEN WE ARRIVED, THERE WERE SEVERAL PATROL SUPERVISORS, SGTS D.HAMILTON AND J.H.PARHAM, ALREADY ON THE SCENE. THE PRIMARY UNIT WAS 20-G-40, OFFICER C.J.BECKER (82658) AND OFFICER V.L.COOK (67730). THESE OFFICERS WERE FLAGGED DONN IN THE AREA IN REGARDS TO ANOTHER MISSING FEMALE. WHILE THEY WERE SEARCHING FOR HER, THEY WERE FLAGGED DOWN AGAIN, BUT THIS TIME BY AN EMPLOYEE OF THE FUDDRUCKERS ON S.KIRKWOOD. HE TOLD THE OFFICERS THAT THE WOMAN WAS BACK IN THE WOODS. HE SAID THAT HE HAD BEEN WALKING HOME AND FOUND HER, HER BEING THE COMPL IN THIS CASE AND NOT THE WOMAN THEY WERE ORIGINALLY FLAGGED DOWN FOR. SHORTLY AFTER FINDING THE #1 COMPL IN THIS CASE, THEY FOUND THE BODY OF THE #2 COMPL LAYING A FEW YARDS AWAY.

THE #1 WAS STILL ALIVE AND AN AMBULANCE WAS CALLED TO THE SCENE FOR HER. WHILE WAITING FOR THE AMBULANCE, SGT HAMILTON TALKED TO HER IN REGARDS TO HER

NAME AND IF SHE KNEW WHO IT WAS THAT ATTACKED HER. AFTER THE AMBULANCE ARRIVED, SHE WAS TRANSPORTED TO WEST HOUSTON HOSPITAL AND THEN TO BEN TAUB. THERE, SHE WAS PRONOUNCED DOA. THE #2 COMPL WAS DOA AT THE SCENE.

IT APPEARS THAT THE MOTIVE FOR THIS CRIME WAS THE SEXUAL ASSAULT OF THE #1 COMPL. ACCORDING TO HER, THE SUSPECT "TRIED TO RAPE" HER. THE COMPL'S WERE STABBED BECAUSE THEY KNEW THE SUSPECT AND COULD IDENTIFY HIM.

THIS SCENE TAKES PLACE ON THE FAR WEST SIDE OF THE CITY OF HOUSTON, IN AND AREA BOUNDED ON THE WEST BY KIRKWOOD, ON THE SOUTH BY WESTEIMER, ON THE EAST BY WILCREST, AND ON THE NORTH BY MEMORIAL DRIVE. IT CAN BE FOUND ON PAGE 489 OF THE KEY MAP.

THE STREET ADDRESS OF THIS INCIDENT IS 2475 S.KIRKWOOD. THIS IS THE ADDRESS OF THE FUDDRUCKER'S RESTAURANT AND THE INCIDENT OCCURRED IN THE VACANT LOT BEHIND THE RESTAURANT. KIRKWOOD IS A NORTH-SOUTH STREET AND THE RESTAURANT IS ON THE EAST SIDE OF THE STREET. THERE IS A CONCRETE DRIVE AND PARKING LOT ALONG THE SOUTH AND BACK SIDES OF THE RESTAURANT. AT ONE TIME, THE LOT BEHIND THE RESTAURANT WAS FENCED WITH BARBED WIRE AND THERE ARE SEVERAL OLD BUILDINGS THAT APPEAR TO BE FARM RELATED. NEXT TO ONE OF THESE BUILDINGS WAS SOME RUSTED FARM IMPLEMENTS.

THE LOT IS OVERGROWN WITH TALL WEEDS. TREES LINE BOTH SIDES AND AROUND THE BUILDINGS. QUITE A BIT OF TRASH HAS BEEN DUMPED IN AND AROUND THIS AREA MAKING IDENTIFICATION OF EVIDENCE DIFFICULT. THERE ARE NUMEROUS TRAILS THROUGH THESE TALL WEEDS BUT THERE ARE TWO MAIN FOOTPATHS THAT RUN GENERALLY EAST-WEST.

THE MAIN TRAIL, THE ONE WITH THE MOST TRAFFIC, APPEARS TO BE THE ONE ON THE SOUTH SIDE OF THE LARGE BURNED OUT BUILDING IN THE CENTER OF THE LOT, DIRECTLY BEHIND THE RESTAURANT. THERE IS ANOTHER WELL USED TRAIL TO THE NORTH OF THE BURNED OUT BUILDING THAT LEADS FROM THE BACK OF THE RESTAURANT TO THE REAR OF TWO APARTMENT COMPLEXES ON EAST SIDE OF THE VACANT LOT. THE COMPLEX TO THE SOUTH IS CALLED THE LAKEWOOD VILLAGE APTS AND THEY CARRY AND ADDRESS OF 11770 WESTEIMER. THE COMPLEX ON THE NORTH IS THE LAKEHURST APARTMENTS. THERE IS A WOODEN FENCE THAT RUNS EAST AND WEST THAT SEPARATES THE TWO COMPLEXES. THIS FENCE ENDS AT THE VACANT LOT AND THERE IS A UTILITY POLE AT THAT LOCATION. THE SECONDARY TRAIL THAT LEADS FROM FUDDRUCKER'S AROUND THE NORTH SIDE OF THE BURNED OUT BUIDING ENDS AT FENCE AND UTILITY POLE. THERE IS A HOLE IN THE FENCE THAT PROVIDES FREE ACCESS TO THE APARTMENT COMPLEX. IT WAS ON THIS TRAIL THAT THE TWO COMPL'S WERE FOUND.

THE #2 COMPL WAS FOUND LAYING JUST OFF THE TRAIL, APPROXIMATELY FORTY FEET DUE WEST OF THE UTILITY POLE AT THE JUNCTION OF THE TWO APT COMPLEXES. THERE WAS A LARGE BLOODSTAIN ON THE GRASS AND THE BODY WAS ON THE NORTH SIDE OF THE TRAIL. HIS HEAD WAS TO THE SOUTHEAST AND FEET TO THE NORTH WEST. THE #1 COMPL WAS ANOTHER 10 TO 15 YARDS WEST. BETWEEN THE TWO LOCATIONS, THERE WERE A COUPLE OF MORE SPOTS OF BLOOD ON THE TRAIL. ANOTHER PIECE OF POSSIBLE EVIDENCE IN THIS AREA WAS A "BUSCH" BEER CAN LAYING IN THE GRASS.

THERE WERE NUMEROUS SIDE TRAILS LEADING OFF THE TWO MAIN TRAILS IN THE LOT. THE FIRST OFFICERS AT THE SCENE HAD A CANINE UNIT EXPLORE THE SURROUNDING AREAS BUT THEY DID NOT LOCATE ANYTHING PERTAINING TO THIS CASE.

THE COMPL WERE IDENTIFIED FROM POLAROIDS PHOTOS BY A FRIEND OF THE FAMILY, CLIFFORD CHILDRESS. WHEN THE COMPLS DIDN'T COME HOME, THE MOTHERS AND MR.CHILDRESS WENT TO THE MANAGERS OFFICE AT LAKEHURST APARTMENTS. THEY HAD KNOWN THAT THE COMPLS HAD BEEN GOING TO THAT COMPLEX WITH THEIR FRIEND, EVELYN. AT THE MANAGERS OFFICE, THE SECURITY GUARD HAD THEM CONTACT SGTS IN THE HOMICIDE DIVISION. SGTS ROSS AND MURRAY THEN WENT AND PICKED THE THREE OF THEM UP AND BROUGHT THEM TO THE HOMICIDE DIVISION. THERE MR.CLIFFORD WAS SHOWN THE POLAROIDS OF THE TWO COMPLS AND HE IDENTIFIED THEM AS SHANDRA CHARLES AND MARCELL TAYLOR.

DRESS OF THE COMPLAINANTS:

THE #1 COMPL WAS WEARING BLUE HALF SHORTS AND A WHITE SHIRT. WHEN OFFICERS FIRST FOUND HER, THE SHORTS WERE UNBUTTONED, UNZIPPED, AND PARTIALLY PULLED DOWN ON HER HIPS, AS WERE HER UNDERWEAR.

THE #2 COMPL WAS WEAR A BLUE SHORT SLEEVE SHIRT WITH A LIGHT BLUE CIRCLE IN THE CENTER. ACROSS THIS CIRCLE WAS THE WORD "SURF". HE WAS WEARING BLUE AND WHITE SHORTS AND SANDALS WITH NO SOCKS. THE TOES OF HIS LEFT FOOT WERE HANGING OUT OF THE SANDAL.

WOUNDS OF THE COMPL:

THE #1 COMPL HAD A STAB WOUND TO THE LEFT SIDE OF HER THROAT AND ANOTHER ONE TO THE LEFT SIDE OF HER CHEST.

THE #2 COMPL HAD TWO STAB WOUNDS TO THE LEFT SIDE OF THE CHEST AND A CUT BEHIND THE LEFT EAR. THERE WAS ALSO A SMALL CUT ON HIS BACK AS IF THE KNIFE PENETRATED FROM THE FRONT TO THE BACK.

SIGNS OF A STRUGGLE :

IT DID NOT APPEAR THAT THERE WAS MUCH OF A STRUGGLE BECAUSE THE BLOODSTAINS ON THE GROUND WERE ON SMALL CIRCLES AND NOT SMEARED AROUND. ALSO, THE GRASS AROUND THE COMPLS HAD BEEN TRAMPLED DOWN BY PEOPLE TRYING TO HELP THE COMPLS SO IT WAS IMPOSSIBLE TO TELL IF THERE WAS A STRUGGLE IN THE GRASS.

************************* HOSPITAL INVESTIGATION

THE #1 COMPL WAS TRANSPORTED TO WEST HOUSTON HOSPITAL, AFTER WHICH, DUE TO HER CONDITION, SHE WAS TRANSFERRED TO BEN TAUB HOSPITAL. SGT.J.L.WALTMON OF THE

HOMICIDE DIVISION DROVE TO BEN TAUB HOSPITAL WHERE HE CONDUCTED THE HOSPITAL INVESTIGATION, AND OFFICER F.L.HALE DROVE TO THE WEST HOUSTON HOSPITAL AFTER CLEARING THE SCENE FOR THE PURPOSE OF OBTAINING SEVERAL ITEMS OF THE COMPLS CLOTHES THAT HAD BEEN RETAINED AT THAT LOCATION. FOR DETAILS OF THESE EFFORTS SEE THE SUPPLEMENTS PREPARED BY THE RESPECTIVE INVESTIGATORS.

DETAILS OF OFFENSE

SGTS.GAFFORD ARRIVED AT THE SCENE APPROXIMATELY 25 MINUTES AFTER RECEIVING THE ASSIGNMENT FROM LT.NEELY. SGTS WERE DIRECTED TO THE REAR OF THE FUDDRUCKERS WHERE SGTS RECEIVED AN OVERVIEW OF THE SITAUTION FROM PATROL OFFICERS, AFTER WHICH SGT.BLOYD BEGAN THE SCENE PORTION OF THE INVESTIGATION AND SGT.GAFFORD BEGAN ATTEMPTING TO INTERVIEW ANY WITNESSES. SGT LEARNED THAT THERE WAS ONLY ONE WITNESS AT THE SCENE, AND DETERMINED THAT THIS WITNESS HAD NO KNOWLEDGE OF THE FACTS OF THIS CASE, BUT HAD BEEN HELD BECAUSE OF HIS BEING IN THE AREA AND REPORTING HIS WIFE MISSING A SHORT TIME EARLIER. THE MALE LATER LOCATED HIS WIFE AND HIS SITUATION WAS RESOLVED, HOWEVER, POLICE HAD ALREADY BEEN CALLED AND WERE IN THE AREA. PATROL OFFICERS WERE FLAGGED DOWN IN THE STOP-N-GO PARKING LOT BY THE WHITE MALE WITNESS, DREW HARTLEY, AND WERE IN THE PROCESS OF LOOKING FOR THE MALES WIFE WHEN THEY OBSERVED AS MALE NAMED JAIME HUNTER TAKING OUT THE TRASH AT THE FUDDRUCKERS RESTAURANT, 2475 S.KIRKWOOD. HUNTER IMMEDIATELY WAVED AT THE OFFICERS AND STATED "SHE'S BACK THERE IN THE WOODS". THE OFFICERS ASKED WHO HUNTER WAS TALKING ABOUT AND HE STATED THAT HE HAD FOUND THE COMPL LAYING IN THE WOODS AS HE WAS WALKING HOME FROM WORK. AFTER FINDING THE COMPL, HUNTER RETURNED TO THE FUDDRUCKERS AND HAD THE MANAGER CALL THE POLICE. IT WAS NOT HOWEVER IN RESPONSE TO THAT CALL THAT POLICE ARRIVED AT THE RESTAURANT, AND IT WAS LATER UNDERSTOOD THAT THE MANAGER HAD JUST REACHED THE POLICE DISPATCHER WHEN THE OFFICERS ARRIVED, AND UPON SEEING THE OFFICERS THE MANAGER DISCONTINUED THE CALL.

OFFICERS COOK AND BECKER WERE DIRECTED TO A WELL WORN PATH THROUGH A GRASSY AND OVERGROWN FIELD WHICH LAY BEHIND THE FUDDRUCKERS, SEPARATING IT FROM THE LAKEHURST APARTMENT COMPLEX WHICH OPENS ONTO CRESCENT PARK. THE OFFICERS ENTERED THE PATH AND FOLLOWED IT TO THE POINT WHERE A BLACK FEMALE, THE #1 COMPL, WAS FOUND LYING FACEDOWN. SEEING THAT SHE WAS ALIVE THE OFFICERS CONTACTED THE DISPTACHER IN AN ATTEMPT TO HAVE AN AMBULANCE SENT TO THE SCENE, AND THE OFFICERS THEN CONTINUED ALONG THE TRAIL IN AN EFFORT TO LOCATE ANY POSSIBLE SUSPECTS. AS THE OFFICERS CONTINUED, THEY WALKED APPROXIMATELY 20-25 FEET BEFORE COMING ACROSS THE BODY OF THE SECOND VICTIM, #2 COMPL, WHERE HE LAY IN THE BRUSH JUST OFF OF THE TRAIL. THIS COMPL APPEARED TO BE DEAD AT THAT TIME.

A NUMBER OF OFFICERS ARRIVED AT THE SCENE TO ASSIST IN THE SEARCH FOR A SUSPECT AND TO LOCATE WITNESSES, ONE OF WHICH WAS SGT.D.HAMILTON, #81397. HAMILTON STATED THAT HE ARRIVED APPROXIMATELY 5 MINUTES AFTER HEARING THE PATROL OFFICERS CALL OUT ON KIRKWOOD. HAMILTON FURTHER STATED WHEN HE ARRIVED THE #1 COMPL, WHOSE NAME WAS UNKNOWN AT THAT TIME, WAS LYING ON THE GROUND IN THE MIDDLE OF THE PATH PREVIOUSLY DESCRIBED. HE STATES THAT THE COMPL WAS BLEEDING FROM THE NECK, AND DESCRIBED THE COMPLS CLOTHING AS A WHITE T-SHIRT WITH WRITING ON IT AND A PAIR OF WHITE SHORTS. SGT. HAMILTON SPOKE WITH THE COMPL, WHO WAS HAVING DIFFICULTY BREATHING, AND HE ASKED HER WHAT HAD HAPPENED. THE COMPL REPLIED "HE TRIED TO RAPE ME", AND HAMILTON ASKED "WHO TRIED TO RAPE

""" THE COMPL STATED "PRESTON", AND HAMILTON ASKED THE COMPL IF SHE KNEW THE MAN THAT
TRIED TO RAPE HER, TO WHICH SHE ANSWERED "YES". HAMILTON ASKED AGAIN WHO IT WAS THAT
TRIED TO RAPE HER AND THE COMPL STATED "PRESTON". THE COMPL
WAS ASKED BY HAMILTON IF SHE KNEW PRESTONS LAST NAME, AND SHE RESPONDED, HOWEVER HAMILTON
WAS NOT ABLE TO UNDERSTAND WHAT WAS SAID. HAMILTON ASKED THE COMPL WHAT HER OWN NAME WAS
AND HE UNDERSTOOD HER TO SAY "LASHANDRA" OR "LASANDA". THE COMPL ALSO TRIED TO TELL THE #2
COMPLS NAME, BUT HAMILTON WAS AGAIN UNABLE TO UNDERSTAND THE COMPL CLEARLY, BUT THOUGHT
THAT THE NAME WAS "MARSHELL" OR "MARCHELL". THE COMPL ALSO STATED THAT THE BOY COMPL WAS
HER COUSIN.

THE #1 COMPL WAS TREATED AT THE SCENE BY HFD AMBULANCE, AFTER WHICH SHE WAS TRANSPORTED TO WEST HOUSTON HOSPITAL. THE #2 COMPL WAS DEAD AT THE SCENE, AND THE #1 COMPLS CONDITION WAS DETERIORATING RAPIDLY, AND SHE WAS THEREFORE REMOVED AS QUICKLY AS POSSIBLE AND TRANSPORTED TO WEST HOUSTON HOSPITAL. THE COMPL WAS LATER TRANSFERRED TO BEN TAUB HOSPITAL WHERE SHE DIED A SHORT TIME LATER.

SGT.GAFFORD SPOKE WITH TWO SECURITY OFFICERS AT THE SCENE WHO ARE PART-TIME SECURITY OFFICERS FOR THE LAKEHURST APTS. THESE OFFICERS LED SGT.GAFFORD TO THE ON-PROPERTY MANAGERS APT, LEISA BARHAM, W/F, WHO VIEWED A POLAROID PHOTO SGT HAD REQUESTED FROM CSU OFFICER HALE OF THE #2 COMPL. THIS WAS BEING DONE TO ATTEMPT TO IDENTIFY THE COMPLS, HOWEVER SHE WAS UNABLE TO MAKE AN IDENTIFICATION. SGT.GAFFORD REQUESTED A COPY OF THE APARTMENT COMPLEX RESIDENT LIST, AND THIS WAS PROVIDED TO SGT BY SECURITY OFFICER NOE GUAJARDO. SGTS GAFFORD AND BLOYD REVIEWED THE LIST WITH A COMPLEX MANAGER, MR.JOE CASLER, WHO HAD BEEN CALLED TO THE SCENE FROM HIS HOME, AND SGTS NOTED A RESIDENT BY THE NAME OF PRESTON HUGHES, WHO RESIDES IN APT #138A. SGTS REQUESTED THAT CASLER GO THE LEASING OFFICE AND PULL THE FILES FOR MR.HUGHES. SGTS DIRECTED PATROL OFFICERS TO TRANSPORT THE TWO WITNESSES (WITNESSES TO THE UNRELATED CASE) TO THE HOMICIDE OFFICE, AND THEN SGTS DROVE TO THE LEASING OFFICE, ACCOMPANIED BY ADDITIONAL PATROL OFFICERS AND SGT.HAMILTON. SGTS REVIEWED HUGHES FILE AND NOTED HIS IDENTIFYING INFO (DOB,SS#, DL#,VEH) AND THEN PROCEEDED TO THE APT, #138A.

SGT.GAFFORD KNOCKED AT THE DOOR, BACKED BY SGTS BLOYD AND HAMILTON, AND THERE WAS NO RESPONSE FOR SOME TIME. SGT HAD THE SECURITY OFFICER GUAJARDO RETURN TO THE LEASING OFFICE TO CHECK FOR A TELEPHONE NUMBER AND ATTEMPT TO CONTACT HUGHES APT BY PHONE. GUAJARDO RETURNED ABOUT 3 OR 4 MINUTES LATER STATING THAT THERE WAS NO TELEPHONE FOR THE APT. SGT HAD CONTINUED KNOCKING AT HUGHES' DOOR DURING THIS TIME, AND AFTER APPROXIMATELY 8 MINUTES, A MALE OPENED THE DOOR OF THE APT. SGT.GAFFORD ASKED THE MALE IF HE WAS PRESTON HUGHES, AND THE MALE REPLIED THAT HE WAS. SGT.GAFFORD ADVISED HUGHES THAT SGTS WERE FROM THE HOMICIDE DIVISION OF THE POLICE DEPARTMENT, AND GAVE SGTS NAMES, AFTER WHICH SGT ASKED IF HUGHES WOULD ALLOW SGTS TO COME INSIDE AND TALK WITH HIM. HUGHES SAID THIS WOULD BE FINE, AND SGTS GAFFORD, BLOYD, AND HAMILTON ENTERED THE APT.

SGTS GAFFORD SPOKE WITH PRESTON IN THE LIVING ROOM OF THE APT FOR SEVERAL MINUTES, ASKING HIM GENERAL QUESTIONS ABOUT WHETHER OR NOT HE LIVED ALONE, AND FINALLY ASKING WHETHER OR NOT HE HAD HAD ANY PROBLEMS WITH ANYONE TONIGHT. HUGHES WAS VERY CALM, AND STATED THAT HE HAD NOT HAD ANY PROBLEMS, HOWEVER HE NEVER ASKED WHY SGTS WERE ASKING THE QUESTIONS. THERE WAS NOTHING TO INDICATE THAT THIS WAS THE CORRECT "PRESTON" AND SGTS, NOT FEELING THAT THIS WAS THE PROPER SETTING TO ASK ANY MORE DIRECT QUESTIONS REGARDING THIS OFFENSE, ASKED HUGHES IF HE WOULD ACCOMPANY SGTS TO THE HOMICIDE DIVISION. HUGHES LOOKED AT HIS WATCH, THE TIME NOW BEING APPROXIMATELY 0230 HOURS, AND STATED THAT HE HAD TO BE LEAVE FOR WORK AT 0500 HOURS. HE THEN SAID THAT HE WOULD GO WITH SGTS. SGT.GAFFORD MADE CLEAR THAT HUGHES WAS BEING ASKED TO VOLUNTARILY

SGT STATED THAT HE COULD AND HE WALKED INTO THE REAR BEDROOM, HUGHES' BEDROOM, AND PUT ON A PAIR OF BLACK JEANS WITH A MAROON BELT, A BLACK SHORT-SLEEVED SHIRT, AND A PAIR OF WHITE AND BLUE TENNIS SHOES. SGT.GAFFORD WAS STANDING IN THE LIVING ROOM AS HUGHES WAS PREPARING TO SECURE THE APT, AND SGT OBSERVED A PAIR OF EYE GLASSES PARTIALLY STUFFED BETWEEN THE CUSHIONS OF THE COUCH. THE GLASSES APPEARED TO HAVE SILVER COLORED FRAMES WITH ROUND EYE-PIECES. IT WAS UNKNOWN TO WHOM THESE BELONGED, AND LITTLE WAS THOUGHT OF IT AT THAT TIME. ALL OFFICERS THEN LEFT THE APT WITH HUGHES EXITING LAST, AND HUGHES SECURED THE DOOR BEHIND HIM. SGTS DIRECTED A PATROL UNIT TO TRANSPORT HUGHES TO THE HOMICIDE DIVISION, AND SGTS THEN LEFT THE COMPLEX TO MEET THEM. OFFICER M.A.VICENTO, #86861, TRANSPORTED HUGHES, WHO WAS NOT HANDCUFFED AND NOT UNDER ARREST, IN THE PATROL VEHICLE.

WHILE SGTS WERE STILL CHECKING BACKGROUND INFORMATION IN AN ATTEMPT TO PREPARE FOR AN INTERVIEW WITH HUGHES A SHORT TIME LATER, SGT.GAFFORD RECEIVED A CALL FROM SECURITY OFFICER MARSHBURN AT THE LAKEHURST APTS. MARSHBURN STATED THAT A FEMALE HAD JUST COME TO THE PROPERTY SEARCHING FOR HER SON, A 3 YEAR OLD BLACK MALE, WHO HAD BEEN IN THE COMPANY OF HIS 15 YEAR OLD COUSIN, BOTH OF WHOM WERE MISSING AT THIS TIME. MARSHBURN STATED THAT THEY HAD NOT TOLD THE FEMALE ANYTHING ABOUT THE INCIDENT, AND THAT THEY HAD SENT HER AWAY AFTER GETTING HER NAME. THE FEMALE, CYNTHIA BROWN, WAS REPORTED TO BE LIVING AT 6301 HAYES RD #6214, #789-9018, AND SHE STATED THAT THE NAMES OF THE COMPLS WERE SHAWN BROWN B/F-15, AND MARCELL BROWN, B/M-3. SGTS ARRANGED FOR THE SECURITY OFFICERS OR MANAGER TO DETAIN THE FEMALE AND CONTACT SGTS SHOULD SHE RETURN TO THE COMPLEX. A FEW MINUTES LATER THE MANAGER, JOE CASERLY, DID CALL SGT.GAFFORD AND HE STATED THAT THE FEMALE WAS AT THE MANAGERS OFFICE AGAIN. SGT.GAFFORD ARRANGED FOR SGT. T.M.ROSS OF THE HOMICIDE DIVISION TO GO THE COMPLEX AND SPEAK WITH THE FEMALE.

SGTS.GAFFORD AND BLOYD ENTERED THE SMALL INTERVIEW ROOM WITHIN THE HOMICIDE OFFICE WHERE HUGHES WAS BEING HELD. SGTS FIRST ENTERED THE ROOM AT APPROXIMATELY 0410 HOURS, AND SGTS AGAIN INTRODUCED OURSELVES. SGTS BEGAN BY ASKING HUGHES FOR HIS FULL NAME, DATE OF BIRTH, SOCIAL SECURITY NUMBER, AND DRIVERS LICENSE NUMBER. SGT THEN ASKED HIM FOR HIS ADDRESS, EMPLOYMENT INFO, AND THEN ABOUT THE SEXUAL ASSAULT CASE WHICH HAD BEEN FILED AGAINST HIM IN 1985. HUGHES GAVE NO HESITATION IN SUPPLYING THE PERTINENT IDENTIFYING INFO, AND THEN STATED THAT HE WAS ON 10 YEARS PROBATION FOR THE SEXUAL ASSAULT CASE. HE CONTINUED THAT HE WAS NOT GUILTY OF THE SEXUAL ASSAULT, BUT WAS FRAMED FOR THAT, AND THAT FURTHER HE HAD BEEN FORCED TO PLEAD GUILTY TO AVOID GOING TO THE PENITENTIARY.

SGTS THEN ASKED HUGHES IF HE KNEW A FEMALE BY THE NAME OF SHAWN. HUGHES STATED THAT HE KNEW ONE GIRL NAMED SHAWN WHO USED TO BE THE GIRLFRIEND OF HIS HIS COUSIN, SHAWN GRAHAM. SGT ASKED WHEN HE LAST SAW HER AND HE STATED THAT HE LAST SAW HER WHEN SHE CAME BY HIS APARTMENT ABOUT TWO MONTHS AGO WITH A GIRLFRIEND NAMED EVELYN, LOOKING FOR SHAWN GRAHAM. SGT ASKED HIM TO DESCRIBE SHAWN AND HE STATED THAT SHE WAS 15 YEARS OLD, A BLACK FEMALE, AND THAT SHE HAD LONG HAIR. SGT ASKED HUGHES HOW SHAWN WORE HER HAIR, AND HE STATED THAT

SHE WORE IT IN BRAIDS. SGT RECOGNIZED THE NAME "EVELYN" THAT HUGHES HAD MENTIONED BECAUSE SECURITY OFFICER MARSHBURN HAD TOLD SGT A SHORT TIME EARLIER, WHEN CYNTHIA BROWN WAS IN THE MANAGERS OFFICE, THAT CYNTHIA HAD TOLD HIM THAT SHAWN WAS COMING TO THE COMPLEX TO VISIT A FRIEND NAMED "EVELYN".

IT NOW BECAME CLEAR TO SGTS THAT, DUE TO: THE NAMING OF "PRESTON" BY THE #1 COMPL AS THE SUSPECT, THE CLOSE PROXIMITY OF PRESTON HUGHES RESIDENCE TO THE MURDER SCENE, AND THE FACT THAT PRESTON HUGHES DOES KNOW BOTH THE COMPL AND EVELYN, SGT.GAFFORD NOW ARRESTED PRESTON HUGHES AS A SUSPECT IN THIS CASE.

SGT.GAFFORD IMMEDIATELY READ HUGHES HIS LEGAL WARNINGS FROM THE BLUE CARD PROVIDED BY THE DISTRICT ATTORNEYS OFFICE, AND AFTER EACH INDIVIDUAL WARNING SGT.GAFFORD ASKED HUGHES IF HE UNDER STOOD THEM. HUGHES STATED, "YES, SIR" EACH TIME HE WAS ASKED ABOUT UNDERSTANDING THE WARNINGS, AND HE FURTHER STATED THAT HE WOULD WAIVE HIS RIGHTS AND TALK TO SGT BECAUSE HE DIDNT DO ANYTHING, AND HAD NOTHING TO HIDE. SGT.GAFFORD LEFT THE ROOM AND CONFERRED WITH SGT.BLOYD ABOUT ANY NEW INFO PRIOR TO BEGINNING ANY FURTHER QUESTIONING. THERE WAS NOTHING TO ADD AT THAT POINT AND SGT.GAFFORD REENTERED THE ROOM AT APPROXIMATELY 0450 HOURS, AFTER HAVING MADE THE ARREST AT 0430 HOURS. DURING THIS INTERVAL HUGHES HAD REQUESTED A CIGARETTE AND SGT PROVIDED ONE.

(FOR COMPLETE DETAILS OF THE INTERROGATION OF HUGHES SEE THE INTERROGATION OF SUSPECT PORTION OF REPORT, THIS WILL BE ADDRESSED ONLY BRIEFLY AT THIS POINT)

FOR SOME TIME HUGHES CONTINUED TO DENY ANY INVOLVEMENT IN THIS INCIDENT, AND HE INSISTED THAT HE HAD NOT SEEN SHAWN IN APPROXIMATELY 2 MONTHS. AFTER HEARING HUGHES' DENIALS FOR A PERIOD OF TIME SGT.GAFFORD PRESENTED HIM WITH A "VOLUNTARY CONSENT FOR SEARCH AND SEIZURE" FORM. SGT HAD FILLED IN HUGHES' NAME AND ADDRESS, PRESTON HUGHES III, 2310 CRESCENT PK #138A, EXPLAINING THAT HE WAS IN NO WAY REQUIRED TO SIGN THE FORM ALLOWING INVESTIGATORS INTO THE APT. HE WAS FURTHER ADMONISHED THAT HE HAD AN ABSOLUTE RIGHT NOT TO CONSENT TO SUCH A SEARCH, YET HUGHES STILL SIGNED THE FORM ALLOWING ENTRY TO THE APT, STATING "I TOLD YOU THAT I DONT HAVE NOTHING TO HIDE". HUGHES SIGNED THE FORM WITNESSES AFFIXED THEIR SIGNATURES AT APPROXIMATELY 0530 HOURS.

SGT.GAFFORD THE CONTINUED THE INTERROGATION, AND AFTER A TIME CONTINUING TO DENY INVOLVEMENT IN THE CASE, HUGHES BROKE DOWN, STATING THAT HE WAS AFRAID TO GO TO JAIL, AND THAT HE DID NOT WANT TO GO TO JAIL. HE ADMITTED AT THIS TIME TO COMMITTING TO THE OFFENSE, AND STATED THAT HE HAD KILLED THE #1 COMPL, HOWEVER WOULD NOT MAKE DIRECT MENTION OF KILLING THE THREE YEAR OLD, EXCEPT TO SAY THAT HE JUST KEPT STABBING DIDNT KNOW WHAT HE WAS HITTING. SGT.GAFFORD WAS IN THE PROCESS OF TYPING THE SUSPECTS WRITTEN STATEMENT WHEN HE STATED, WHILE POINTING TO THE VOLUNTARY CONSENT FOR SEARCH AND SEIZURE FORM, "I GUESS YOU'RE LOOKING FOR THE KNIFE". PRIOR TO THE SUSPECTS SAYING THAT HE JUST "KEPT STICKING" THE PERSON WITH A KNIFE, AND HIS STATEMENT ABOUT SGTS LOOKING FOR THE KNIFE, SGTS HADNT MENTIONED TO THE SUSPECT THE METHOD BY WHICH THE COMPLS WERE KILLED. AS THIS WAS DURING THE VERY EARLY MORNING HOURS, THERE HAD BEEN NO NEWS REPORTS OR ARTICLES BY THE WHICH THE SUSPECT COULD HAVE LEARNED THAT THE INCIDENT WAS A STABBING, AND THEREFORE IT WAS CLEAR THAT THE SUSPECT HAD DIRECT KNOWLEDGE OF THE INCIDENT. THE SUSPECT GAVE A DETAILED DESCRIPTION OF THE LOCATION OF THE MURDER WEAPON, AS WELL AS THE CLOTHING HE WAS WEARING AT THE TIME, AND SGTS GAFFORD PASSED THIS INFORMATION ALONG TO SGTS D.FERGUSON AND E.T.YANCHAK, OF THE DAYSHIFT HOMICIDE DIVISION, AND THEY SUBSEQUENTLY DROVE TO THE SUPSECTS APT AND RECOVERED THESE AND OTHER ITEMS OF EVIDENCE.

AFTER COMPLETION OF THE WRITTEN STATEMENT SGT.GAFFORD PRESENTED PRESTON HUGHES WITH A "VOLUNTARY CONSENT FOR TAKING OF SAMPLES OF BLOOD, URINE, OR HAIR. SGT.GAFFORD EXPLAINED THIS FORM TO THE SUSPECT IN THE SAME MANNER AS HAD BEEN DONE WITH THE VOLUNTARY CONSENT FOR SEARCH AND SEIZURE FORM, AND HE STATED THAT HE "MIGHT AS WELL NOT HOLD ANYTHING BACK NOW", AND HE SIGNED THE FORM, KNOWING THAT HE HAD A RIGHT NOT TO SIGN THE FORM. THIS FORM WAS RETAINED WITH THE CASE FILE AFTER BEING WITNESSED AT APPROXIMATELY 0745 HOURS BY SGTS.BLOYD AND ROSS. THE SUSPECT WAS OFFERED AND ACCEPTED A NUMBER OF CIGARETTES AND A COLD DRINK (COKE) DURING THE TIME HE WAS BEING INTERVIEWED, AND SGT WILL ELABORATE ON THIS AT A LATER TIME.

INTERVIEWS WITH WITNESSES

THERE WERE NO KNOWN WITNESSES TO THE ACTUAL STABBING INCIDENT EXCEPTING THE DECEASED COMPLS AND THE SUSPECT. THE UNIFORMED PATROL OFFICERS HAD DETAINED A MALE, AND KNEW THE LOCATION OF THE MALES WIFE, WHO HAD CALLED THE POLICE A SHORT TIME BEFORE THE COMPLS WERE DISCOVERED. THESE WITNESSES ARE KNOWN IN THE AREA FROM PAST INCIDENTS, AND ARE KNOWN BY AREA OFFICERS TO BE SOMEWHAT UNSTABLE, A CONDITION WHICH SGT OBSERVED THIS DATE AS WELL. THE INFORMATION PROVIDED BY THESE WITNESSES DOES NOT APPEAR RELEVANT TO THIS CASE, WITH THE MOST IMPORTANT EXCEPTION BEING THEIR CALL WAS THE ONE WHICH POLICE IN THE AREA AT THE TIME OF THE DISCOVERY OF THE COMPLS IN THIS CASE. THESE MALE AND FEMALE WERE TRANSPORTED TO THE HOMICIDE DIVISION WHERE WRITTEN STATEMENTS WERE OBTAINED, AND THEY WERE THEN RELEASED. SGT.GAFFORD ALSO TOOK WRITTEN STATEMENTS FROM THE FUDDRUCKERS EMPLOYEE, AND SGT SPOKE WITH THE SECURITY GUARDS AND MANAGEMENT OF THE LAKEHURST APT PROJECT WHILE AT THE SCENE. DREW STATES HE AND HIS WIFE WERE ON THEIR WAY FROM THE LAKEWOOD APTS TO THE STORE, AND WERE WALKING IN THE WOODED AREA NEAR A CAR WASH. (THIS AREA IS NOT TH SAME WOODED AREA THAT IS BEHIND THE FUDDRUCKERS WHERE THE COMPLS WERE FOUND, BUT IT IS AN EXTENSION OF THAT SAME EASEMENT). THEY HEARD MOVEMENT IN THE BRUSH AND THOUGHT THEY WERE BEING CHASED AND RAN TO A STOP-N-GO WHERE HIS WIFE CALLED POLICE. DREW LOST TRACK OF HIS WIFE AT ONE POINT NEAR THE CAR WASH A SHORT TIME LATER, AND HE BEGAN SEARCHING FOR HER, ENLISTING THE AID OF A CIVILIAN AND ALSO THE OFFICERS WHO WERE RESPONDING TO THE CALL. BARBARAS STORY IS MUCH THE SAME AS DREWS AND SHE STATES THAT AFTER SHE CAUGHT A RIDE WITH THE MALES AT THE CAR WASH, SHE RODE AROUND WITH THEM FOR A WHILE AND THEN ASKED THEM TO DROP HER OFF AT THE FRIENDS APT AT THE LAKEWOOD COMPLEX. THEY DID SO AND SHE WAS FOUND THERE LATER BY PATROL OFFICERS. SHE WAS BROUGHT TO THE HOMICIDE DIVISION AND A WRITTEN STATEMENT WAS OBTAINED BY SGT.C.R.WILLIAMS. SHE DESCRIBED A "SHAPE" SHE OBSERVED IN THE BUSHES AS THAT OF A BLACK MALE WITH AN AFRO.

MARSHBURN STATED THAT HE FIRST BECAME AWARE OF THE INCIDENT WHEN HE OBSERVED THE POLICE HELICOPTER AND POLICE OFFICERS IN THE AREA. HE LATER CALLED GUAJARDO TO THE SCENE. THEY DID NOT RECOGNIZE THE COMPLS, AND ESCORTED SGT TO MGR. LEISA BARHAM WHO WAS ALSO UNABLE TO IDENTIFY THE #2 COMPL PICTURED IN A POLAROID PHOTO BY HALE. SGT.GAFFORD OBTAINED A LIST OF THE CURRENT LIST OF RESIDENTS (THE LIST WAS ONE WEEK OLD) FROM GUAJARDO, AND IT WAS ON THIS LIST THAT SGTS FOUND THE NAME OF THE MALE WHO WAS LATER DEVELOPED AS THE SUSPECT IN THIS CASE. MARSHBURN CONTACTED THE PROJECT MANAGER, JOE CASLER, VIA THE SECURITY COMPANY AND HAD HIM COME TO THE SCENE. AFTER SGTS LEFT THE SCENE AND RETURNED TO THE HOMICIDE DIVISION MARSHBURN CALLED SGT.GAFFORD AND ADVISED THAT THE COMPLS FAMILY WAS AT THE LOCATION LOOKING FOR THE #2 COMPL, NOT THEN BEING AWARE THAT THIS OFFENSE HAD OCCURRED.

JOE CASLER ARRIVED AT THE SCENE AFTER BEING REQUESTED BY SGT.GAFFORD. CASLER ALLOWED SGTS TO LOOK AT THE RESIDENT FILE FOR THE SUSPECT, PRESTON HUGHES, WHO LIVED IN APT 138A, 2310 CRESCENT PARK. SGTS OBTAINED A COPY OF THE APPLICATION FOR RENTAL FROM THE FILE. CASLER LATER CONTACTED THE HOMICIDE OFFICE AND ADVISED SGT.GAFFORD THAT CYNTHIA BROWN HAD RETURNED TO THE PROJECT ASKING QUESTIONS ABOUT THE "MISSING" COMPLS. SGT ADVISED CASLER TO DETAIN THE FEMALE UNTIL SGT. ROSS OF THE HOMICIDE DIVISION COULD DRIVE TO THE LOCATION AND MAKE CONTACT WITH HER.

INTERROGATION OF SUSPECT

AFTER THE SUSPECT AGREED TO VOLUNTARILY ACCOMPANY SGTS.GAFFORD AND BLOYD TO THE HOMICIDE OFFICE, HE WAS INTERVIEWED BRIEFLY REGARDING HIS KNOWLEDGE OF THE #1 COMPL IN THIS CASE. AS SOON AS IT WAS DETERMINED THAT HUGHES WAS THE CORRECT PRESTON THAT HAD REFERRED TO BY THE COMPL BEFORE HER DEATH, SGT.GAFFORD ARRESTED THE SUSPECT (IN THE HOMICIDE OFFICE AT 0430 HOURS) AND READ HIM HIS LEGAL WARNINGS FROM THE BLUE CARD SUPPLIED BY THE DISTRICT ATTORNEYS OFFICE. SGT.GAFFORD READ EACH WARNING INDIVIDUALLY, AND AFTER EACH ONE SGT WOULD STOP AND ASK THE SUSPECT IF HE UNDERSTOOD THE WARNINGS. THE SUSPECT STATED "YES,SIR" EACH TIME HE ASKED ABOUT HIS UNDERSTANDING OF THE WARNINGS, AND HE THEN STATED THAT HE WOULD TALK TO SGT ABOUT THE CASE. THE SUSPECT APPEARED INTELLIGENT, AND GAVE EVERY INDICATION OF BEING LITERATE AND CAPABLE OF UNDERSTANDING WHAT WAS BEING SAID, AND IT SGTS BELIEF THAT THE SUSPECT FULLY UNDERSTOOD THE WARNINGS.

THE SUSPECT REQUESTED A CIGARETTE, AND SGT.GAFFORD OBTAINED ONE FOR HIM FROM LT.NEELY OF THE HOMICIDE DIVISION. THE SUSPECT SMOKED THE CIGARETTE WHILE SGT GAFFORD CONFERRED BRIEFLY WITH SGT.BLOYD, AND SGT.GAFFORD RETURNED TO THE INTERVIEW ROOM AT 0450 HOURS. SGT WENT OVER THE SEQUENCE OF EVENTS OF THE SUSPECTS DAY, AND LEARNED THAT THE SUSPECT WENT TO WORK AND GOT OFF AT APPROX 6:30PM. HE WAITED FOR A FRIEND AND THEN HE AND SEVERAL BUDDIES WENT TO A LIQUOR STORE ON THE CORNER NEAR FRANKLIN AND AUSTIN STREETS DOWNTOWN. THEY DRANK ON THE PARKING LOT UNTIL ABOUT 10 MINUTES AFTER 8PM, AND AT THAT TIME TWO OF THE FRIENDS DROPPED HIM OFF AT FANNIN AND WALKER TO CATCH THE BUS. SKIPPING SEVERAL OF THE STATEMENTS DETAILS, HUGHES RODE FELL ALSEEP ON THE BUS AND ENDED UP AT END OF THE ROUTE AT HWY 6 AND WESTHEIMER. HUGHES CALLED A CAB AND WAS TAKEN HOME TO THE LAKEHURST APTS. HE STATED THAT HE WENT INTO THE APT AND CHECKED THE FOOTBALL GAME SCORE AND AFTER THAT HE WENT TO BED.

SGT.GAFFORD SPOKE WITH THE SUSPECT ABOUT THESE DETAILS FOR ABOUT 20 MINUTES AND HE WOULD STILL NOT WAIVER FROM HIS STATEMENT. WHEN TALKING ABOUT HIS PAST RECORD THE SUSPECT MENTIONED THAT THE FEMALES HE HAD HAD PROBLEMS WITH IN THE PAST WERE LIGHT SKINNED BLACK FEMALES, AND HE STATED THAT THE "YELLOW" GIRLS ARE NO GOOD, AND THAT THEY ARE "ALL STUCK UP AND SHIT" AND THAT THEY WERE ALWAYS MESING WITH HIM. SGT NOTED A GREAT DEAL OF TENSION WHEN THE SUSPECT WAS TALKING ABOUT THIS, AND

FURTHER CONNECTED THIS WITH AN EARLIER STATEMENT HE HAD MADE WHEN DESCRIBING THE "SHAWN" HE KNEW AS BEING A "YELLOW" SKINNED 15 YEAR OLD FEMALE. HE STATED THAT HE HAD LAST SEEN THE COMPL APPROX 2 MOS AGO, AND THAT SHE WORE HER HAIR IN BRAIDS.

IT WAS APPROXIMATELY 0520 HOURS WHEN SGT.GAFFORD PRESENTED HUGHES WITH THE VOLUNTARY CONSENT FOR SEARCH AND SEIZURE FORM. AS REPORTED EARLIER IN THIS SUPPLEMENT THE SUSPECT SIGNED THE FORM AFTER BEING PROPERLY INSTRUCTED ON HIS RIGHTS AND THE USE OF THE FORM. THE FORM WAS WITNESSED BY SGTS.BLOYD AND ROSS AT APPROXIMATELY 0530 HOURS.

THE SUSPECT REQUESTED ANOTHER CIGARETTE AND SGT.GAFFORD AGAIN OBTAINED ONE FOR HIM AS SGT AGAIN STARTED QUESTIONING HIM ABOUT THE INCIDENT. SGT.GAFFORD LISTENED TO THE SUSPECT CONTINUE TO DENY INVOLVEMENT IN THE DEATHS OF THE COMPLS UNTIL APPROXIMATELY 0540 HOURS WHEN SGT CONFRONTED THE SUSPECT WITH THE FACT THAT THE COMPL WAS GIVEN HIS NAME AS THE ONE WHO HAD STABBED SHE AND THE #2 COMPL. THE SUSPECT WAS VISIBLY UPSET BY THIS FACT AND SGT CONTINUED THAT IT WAS SGTS FIRM BELIEF THAT HE WAS IN FACT THE ONE THAT HAD STABBED THEM. THE SUSPECT HAD NOT BEEN TOLD THE CONDITION OF THE #1 COMPL, BUT WAS AWARE OF THE

#2 COMPLS DEATH, ALTHOUGH HE HAD PREVIOUSLY DENIED KNOWING WHO SGT WAS TALKING ABOUT IN REFERENCE TO MARCELL TAYLOR.

THE SUSPECT BEGAN TO TREMBLE AND STATED, "I JUST DONT WANT TO GO TO JAIL". SGT WAITED AS THE SUSPECT CONTINUED TO THINK TO HIMSELF. SGT THEN ASKED THE SUSPECT IF HE WANTED TO TALK ABOUT WHAT HAD HAPPENED. THE SUSPECT SAID THAT HE DIDNT MEAN TO HURT ANYONE. THE WENT INTO A NARRATIVE ABOUT WHAT SEEMED TO BE AN UNRELATED INCIDENT, BUT THE SUSPECT LATER TIED THAT INCIDENT TOGETHER WITH THE KILLING OF THE COMPLS. JUST A FEW MINUTES PRIOR TO THE SUSPECT BREAKING DOWN, THE SUSPECT REQUESTED THAT SGT GET HIM A COKE AND A PACK OF CIGARETTES, WHICH SGT DID. DURING THE TIME THAT THE SUSPECT WAS GIVING THE STATEMENT HE WAS DRINKING THE COKE AND SMOKING THE CIGARETTES, AND HE WAS SEATED IN A PADDED CHAIR IN A COMFORTABLE POSITION. HE WAS NOT HANDCUFFED, AND HAD NOT BEEN AT ANY TIME PRIOR SINCE HE WAS NOT ARRESTED UNTIL AFTER HIS ARRIVAL IN THE HOMICIDE OFFICE.

IN SHORT, THE SUSPECT STATED THAT ABOUT TWO WEEKS AGO HE WAS ACCUSED OF SEXUALLY ASSAULTING A GIRL BY THE NAME OF LINDA. HE STATED THAT HE WAS NOT GUILTY OF THAT INCIDENT AND PROVED IT SO HE WAS NEVER ARRESTED, ONLY QUESTIONED. HE STATES THAT LINDA'S BROTHERS AND HUSBAND, HOWEVER, BELIEVE HE DID ASSAULT HER, AND THEY HAVE MADE THREATS AGAINST HIS LIFE. DUE TO THIS FEELING THAT THEY ARE AFTER HIM, THE SUSPECT BEGAN TWO WEEKS AGO CARRYING A KNIFE. THE KNIFE WAS DESCRIBED AS AN ARMY KNIFE WITH A 5" OR 6" FIXED BLADE WHICH HE WORE IN A SHEATH ON HIS BELT.

PRESTON HUGHES STATED THAT TONIGHT HE WAS WALKING ON THE TRAIL BETWEEN THE THE APT COMPLEX AND THE FUDDRUCKERS AND SOMEONE WALKED UP BEHIND HIM AND TOUCHED HIM ON THE SHOULDER. HE STATED THAT HE THOUGHT IT WAS ONE OF THE BROTHERS TRYING TO KILL HIM, AND THEREFORE HE JUST TURNED AND THREW A BLOCK WITH HIS LEFT ARM, AND STARTING STABBING WITH THE KNIFE IN HIS RIGHT HAND. HE EXPLAINED THAT HE WAS STABBING BOTH HIGH AND LOW, AND THAT AFTER THE FIRST COUPLE OF STABBING MOTIONS HE REALIZED THAT IT WAS SHAWN. HE SAID THAT HE COULDN'T BELIEVE IT AND THEN GOT SCARED AND CRAZY, AND JUST KEPT ON STABBING AT HER, 6,8,OR POSSIBLY 10 TIMES. HE MAINTAINED THAT HE WAS VERY SCARED AND SO HE RAN BACK TO HIS APT, BUT THAT THE FIRST THING HE DID WAS TURN ON THE T.V.AND CHECK THE SCORE ON THE FOOTBALL GAME BECAUSE HE HAD A BET ON THE GAME FOR THE DENVER BRONCOS TO LOOSE. HE TOOK OFF HIS CLOTHES AND WAS WEARING A PAIR OF RED SHORTS AND WALKED OUTSIDE A SHORT TIME LATER TO LET THE DOG IN. HE WENT DOWNSTAIRS AND THE DOG WANTE TO PLAY IN THE PARKING LOT, SO HE STATES HE RAN BACK AND FORTH A FEW TIMES WITH THE DOG. HE THEN SAW THE POLICE HELICOPTER FLY OVER AND IT SHINED THE SPOTLIGHT ON HIM, SO HE WENT INSIDE. HUGHES STATED THAT HE TOOK THE KNIFE OFF OF HIS BELT, AND HID IT IN A BOX IN THE CLOSET. HE LEFT HIS CLOTHES LAYING ON THE FLOOR AND WENT TO BED. IT WAS A LITTLE WHILE LATER WHEN SGTS.GAFFORD AND BLOYD KNOCKED AT THE DOOR.

DURING THE TIME THAT THE STATEMENT WAS BEING TAKEN, PRESTON HUGHES DID NOT APPEAR EMOTIONAL ABOUT THE FACT THAT HE HAD KILLED ANYONE. THE ONLY CONCERN THAT HE VOICED THAT IF HE DIDN'T GET TO WORK TOMORROW HE WOULD LOOSE HIS JOB. SGT GAFFORD HAD THE SUSPECT SIGN EACH PAGE INVIDIDUALLY AS IT WAS COMPLETED, AND SGT WOULD THEN GO TO THE NEXT PAGE. THE STATEMENT CONSISTED OF THREE TYPED PAGES, WITH THE FIRST BEGINNING AT 0555 HOURS, THE SECOND BEGINNING AT 0613 HOURS, AND THE THIRD BEGINNING AT 0633 HOURS. PRIOR TO SIGNING EACH PAGE OF THE STATEMENT THE SUSPECT READ THE PAGE, AND ONCE THE ENTIRE STATEMENT WAS COMPLETE THE SUSPECT RE-READ THE ENTIRE STATEMENT. THE SUSPECT TOLD SGT THAT THIS WAS THE WAY THAT THE INCIDENT HAD HAPPENED.

SGTS SPOKE WITH THE SUSPECT ABOUT THE CIRCUMSTANCES SURROUNDING THE GIVING OF THE STATEMENT. SGT.GAFFORD REMAINED IN THE ROOM FOR A FEW MOMENTS AND THEN LEFT THE ROOM SO THAT ROSS AND SMITH COULD QUESTION THE SUSPECT TO INSURE THAT THE STATEMENT HAD BEEN VOLUNTARY. AFTER COMPLETING THIS PROCESS, SGTS SMITH AND ROSS AFFIXED THEIR SIGNATURES TO THE STATEMENT AS WITNESSES AT APPROXIMATELY 0715 HOURS.

SGT.GAFFORD PREPARED A "VOLUNTARY CONSENT FOR TAKING OF SAMPLES OF BLOOD, URINE, OR HAIR", WHICH WAS PRESENTED TO THE SUSPECT FOR HIS SIGNATURE. SGT EXPLAINED THE FORM TO HIM, DETAILING THAT HE HAD A RIGHT NOT TO SIGN THE FORM, AND HE STATED THAT HE WOULD GIVE WHATEVER WAS NEEDED, AND SIGNED THE FORM. SGTS BLOYD AND ROSS SIGNED THIS FORM AS WITNESSES AT APPROXIMATELY 0745 HOURS, 9/27/88.

THE SUSPECT WAS LEFT SITTING IN THIS INTERVIEW ROOM AND AS SGT.GAFFORD WAS LEAVING THE ROOM, THE SUSPECT ASKED IF HE USE THE TELEPHONE TO CALL HIS BOSS. SGT. BROUGHT A PHONE INTO THE ROOM AND THE SUSPECT CALLED HIS BOSS. HE THEN MADE A NUMBER OF OTHER PHONE CALLS, TO HIS AUNTIE, AND OTHERS, AND THESE WERE NOT RESTRICTED BY SGTS. AFTER THE SUSPECT WAS THROUGH WITH THE TELEPHONE, SGT REMOVED IT FROM THE ROOM AGAIN. THE SUSPECT DID NOT WANT TO BE PLACED IN THE CITY JAIL UNTIL IT WAS ABSOLUTELY NECESSARY, AND THEREFORE SGT PERMITTED HIM TO REMAIN IN THE INTERVIEW ROOM FOR THE TIME BEING. THE SUSPECT WAS ALLOWED TO SMOKE AS HE WISHED, AND SGTS WOULD PROVIDE HIM A LIGHT WHEN NECESSARY.

SGT.GAFFORD CONFERRED WITH SGTS.FERGUSON AND YANCHAK WHO WOULD BE CONTINUING THE INVESTIGATION AND THEY ALSO INTERVIEWED THE SUSPECT VERY BRIEFLY. HUGHES REQUESTED THAT HE BE ALLOWED TO MAKE AN ADDITIONAL TELEPHONE CALL, AT WHICH TIME HE CALLED HIS PROBATION OFFICER, MICHAEL KLUMP, #953-8200. AFTER COMPLETING THE CALL THE SUSPECT STATED THAT HE FELT LIKE KLUMP WAS GOING TO START PROCEEDINGS TO REVOKE HIS PROBATION ON THE SEXUAL ASSAULT CASE FROM 1985. SGT. GAFFORD TOOK POSSESSION OF THE SUSPECTS MAROON BELT AND HIS WHITE AND BLUE "DIADORA" TENNIS SHOES, BOTH OF WHICH HUGHES STATED HE WAS WEARING AT THE TIME OF THE OFFENSE. THESE ITEMS WERE LATER TURNED OVER TO OFF.HILLEMAN OF THE CSU SECTION TO BE PLACED IN THE PROPERTY ROOM UNDER THIS CASE NUMBER. SGTS.GAFFORD AND BLOYD THEN ESCORTED THE SUSPECT TO THE CITY WHERE HE WAS BOOKED IN AT APPROXIMATELY 0930 HOURS.

INTRODUCTION:

ON TUESDAY, SEPTEMBER 27 1988 AT APPROXIMATELY 0005HRS, I, OFFICER F.L. HALE BEING ASSIGNED TO THE CRIME SCENE SECTION AND RIDING CSU 14 RECEIVED AN ASSIGNMENT FROM HOMICIDE LIEUTENANT. OFFICER HALE WAS INFORMED THAT A CHILD HAD BEEN KILL AND A FEMALE WAS IN SERIOUS CONDITION. THE SCENE WAS AT 2400 S KIRKWOOD. PATROL OFFICERS WERE ON THE SCENE. THE #2 COMPLAINANT WAS STILL AT THE SCENE DOA. THE #1 COMPLAINANT (FEMALE) WAS TRANSPORTED TO THE HOSPITAL.

AT THIS TIME I CLEARED CENTRAL AND WENT DIRECTLY TO THE SCENE. UPON ARRIVING AT APPROXIMATELY 0035HRS, I, MET WITH HOMICIDE DETECTIVES BLOYD AND GAFFORD. THE SCENE WAS LOCATED BEHIND FUDDRUCKERS, LOCATED IN THE 2400 BLOCK OF S. KIRKWOOD, NORTH OF WESTHEIMER. THE SCENE OCCURRED IN A FIELD BEHIND THE BUSINESS. OFFICER HALE WAS LEAD DOWN A SMALL TRAIL AND SHOWN SEVERAL SPOT OF BLOOD ON THE DIRT AND GRASS, THIS BEING THE LOCATION WHERE THE FEMALE COMPLAINANT WAS FOUND. FURTHER EAST WAS THE MALE COMPLAINANT. HE WAS FOUND IN A GRASSY AREA. THE AREA SURROUNDING THE MALE WAS MATTED DOWN. THERE WAS TWO LARGE SPOTS OF BLOOD NEAR THE MALE. ALSO, SOUTHWEST OF THE MALE COMPLAINANT WAS A WHITE SHOULDER PURSE STRAP. THE STRAP HAD LOOP KNOTS TIED AT BOTH ENDS.

BETWEEN THE AREA OF THE TRAIL, FROM WHERE THE COMPLAINANT'S WERE WAS AN EMPTY BUSCH BEER CAN, WHICH APPEARED TO BE FRESH. THE BEER CAN WAS CLEAN AND HAD A SMALL AMOUNT OF CONDENSATION ON THE OUTSIDE. THIS BEER CAN WAS RESTING IN THE TALL GRASS.

THE TRAIL STARTED AT THE NORTHEAST CORNER OF THE BACK PARKING LOT OF FUDDRUCKER'S. THE TRAIL RAN BASICALLY EAST/WEST AND WAS USED AS A SHORT CUT BETWEEN THE APARTMENT COMPLEXES ON THE EAST SIDE OF THE TRAIL AND FUDDRUCKERS.

SUPPLEMENT NARRATIVE

OFFICERS RIDING UNIT 20G40 WERE FLAGGED DOWN BY A PERSON KNOWN AS DREW CURTIS HARTLEY REGARDING HIS WIFE MISSING. THE TIME WAS APPROX 2330 HRS AND THE LOCATION WAS THE STOP N GO PARKING LOT AT 2303 S. KIRKWOOD.

HARTLEY STATED HIS WIFE HAD BEEN WALKING IN A CAR WASH BAY LOCATED EAST OF THE STOP N GO. HE STATED POSSIBLY TWO BLACK HAD ABDUCTED HER AND DRUG HER INTO THE FIELD LOCATED SOUTH OF THE STOP N GO: HARTLEY HAD A FLASHLIGHT IN HIS HAND AND STATED HE HAD BEEN LOOKING FOR HIS WIFE FOR A WHILE.

OFFICERS DROVE FROM THE STOP N GO AND BEGAN LOOKING INTO A FIELD IN THE 2400 BLK OF S. KIRKWOOD. THE FIELD IS DENSE WITH HIGH BRUSH AND WEEDS AND IS SURROUNDED BY THE STOP N GO AND CAR WASH ON THE NORTH, THE LAKEHURST APTS 2310 CRESCENT PK ON THE EAST, S. KIRKWOOD STREET ON THE WEST AND FUDDRUCKERS RESTAURANT 2475 S. KIRKWOOD ON THE SOUTH. OFFICERS OBSERVED A WHITE MALE LATER KNOWN AS JAIME HUNTER TAKING OUT THE TRASH FROM THE RESTAURANT. HUNTER FLAGGED OFFICERS DOWN AND STATED "SHE'S BACK THERE IN THE WOODS!" OFFICERS ASKED "WHO IS BACK THERE?" HUNTER REPLIED "I WAS WALKING HOME AND FOUND HER LAYING IN THE WOODS". SMITH AND ROSS THEN SIGNED AS WITNESSES ON THE APPROPRIATE LINES ON ALL THREE PAGES. SGT.
