

## Records Relating to the Trial and Execution of Peter Thomas Anthony Manuel

Recent media interest has centred on the convicted murderer Peter Manuel who was executed in July 1958. Manuel was hanged in Barlinnie prison in Glasgow almost 50 years ago, following trial and conviction for the murder of seven people in the West of Scotland. He remains one of Scotland's most notorious serial killers.

The National Archives of Scotland (NAS) holds many records about the Manuel case, in particular the investigation by the police and his prosecution by the Crown Office, his trial at the High Court of Justiciary in Glasgow in May 1958, during which he dismissed his counsel and conducted his own defence, and Manuel's prison files and execution. Most of these records have been open to the public for many years, though a small number remain exempt or restricted, and are therefore closed to public inspection.

To facilitate further research on the Manuel case, we have published details about the records we hold and their current access status under either the Freedom of Information (Scotland) Act 2002 or the Data Protection Act 1998.

### Records Relating to the Trial and Execution of Peter Thomas Anthony Manuel

#### Part 1: Crown Office Records

Crown Office files are subject to both the Freedom of Information (Scotland) Act 2002 and the Data Protection Act 1998.

The NAS holds the following Crown Office files concerning the trial of Peter Manuel. Most of the information the files contain has been reviewed by the Crown Office under Freedom of Information (FOI) and has been deemed either open or exempt. Open information may be viewed in the NAS's public search room at West Register House (for details see <a href="http://www.nas.gov.uk/searchRooms">http://www.nas.gov.uk/searchRooms</a>). The files are out-housed so we require 24 hours notice to produce them. Where the Crown Office considers that information comes under one of the FOI exemptions, this is made clear in the table below. Under FOI, the Crown Office must review these decisions in the light of any further requests to view this information.

Before the Freedom of Information (Scotland) Act came into force in January 2005, many Crown Office records were closed for 75-100 years. As it was impossible to undertake a wholesale review of all Crown Office files when FOI came into force, this term is still in use for items which have not yet been the subject of a Freedom of Information request.

### Part 2: High Court of Justiciary Records

High Court records are not subject to the Freedom of Information (Scotland) Act 2002 but are subject to the Data Protection Act, 1998.

The main High Court material concerning the trial of Peter Manuel which NAS holds is listed below. In addition to this, mention of him will also appear in other High Court series associated with trials and appeals – eg Glasgow circuit books of adjournal (ref: JC15) and minute books (ref: JC13-14). In order to ensure that Data Protection considerations are not breached, the High Court restricts access to material less than 75 years old, requiring anyone wishing to consult it to apply for written permission to do so. The only exception to this is for access to High Court minute books, which do not normally name victims and are therefore open for consultation. Open information may be viewed in the NAS's public search room at West Register House (for details see <a href="http://www.nas.gov.uk/searchRooms">http://www.nas.gov.uk/searchRooms</a>). If written permission is given to view restricted material, it can also be viewed at West Register House. Some of the items listed in the table below are out-housed so we require 24 hours notice to produce them.
