The grand jurors of Pinal County, Arizona, accuse **CONNIE VILLA**, charging that in Pinal County, Arizona.

**COUNT 1**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed First Degree Murder by, causing the death of ██████, with premeditation, intending or knowing that her conduct would cause that death, in violation of A.R.S. §§13-1105(A)(1), 13-3601, 13-610, 13-13-705, 701, 13-702, 13-712, and 13-801, a class 1 Felony, Dangerous Crime Against Children, first degree.

**COUNT 2**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed Attempted First Degree Murder by, attempting to cause the death of ██████ with premeditation, intending or knowing that her conduct would cause that death, in violation of A.R.S. §§13-1105(A)(1), 13-1101, 13-705, 13-1001, 13-3601, 13-702, 13-702.01, 13-703, 13-801, a class 2 Dangerous felony, Dangerous Crime Against Children, first degree.

**COUNT 3**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed Attempted First Degree Murder by, attempting to cause the death of ██████ with premeditation, intending or knowing that her conduct would cause that death, in violation of A.R.S. §§13-1105(A)(1), 13-1101, 13-705, 13-1001, 13-3601, 13-702, 13-702.01, 13-703, 13-801, a class 2 Dangerous felony, Dangerous Crime Against Children, first degree.

**COUNT 4**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed Attempted First Degree Murder by, attempting to cause the death of ██████ with premeditation, intending or knowing that her conduct would cause that death, in violation of A.R.S. §§13-1105(A)(1), 13-1101, 13-705, 13-1001, 13-3601, 13-702, 13-702.01, 13-703, 13-801, a class 2 Dangerous felony, Dangerous Crime Against Children, first degree.

**COUNT 5**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed Attempted First Degree Murder by, attempting to cause the death of [REDACTED] with premeditation, intending or knowing that her conduct would cause that death, in violation of A.R.S. §§13-1105(A)(1), 13-1101, 13-705, 13-1001, 13-3601, 13-702, 13-702.01, 13-703, 13-801, a class 2 Dangerous felony.

**COUNT 6**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed Kidnapping by knowingly restraining [REDACTED] with the intent to inflict death, physical injury or a sexual offense upon him/her, or to otherwise aid in the commission of a felony, in violation of A.R.S §§13-1304 (A)(3), 13-1301, 13-3601, 13-705, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 2 Dangerous felony, Dangerous Crime Against Children, first degree.

**COUNT 7**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** intentionally and knowingly committed Child Abuse by, under circumstances likely to cause death or serious physical injury, causing physical injury to [REDACTED], or having the care or custody of such a child, causes or permits the person or health of such child to be placed in a situation where his physical health is endangered, in violation of A.R.S. §§13-3623(A)(1), 13-3601, 13-705, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 2 felony, Dangerous Crime Against Children, first degree.

**COUNT 8**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** intentionally and knowingly committed Child Abuse by, under circumstances likely to cause death or serious physical injury, causing physical injury to [REDACTED] or having the care or custody of such a child, causes or permits the person or health of such child to be placed in a situation where his physical health is endangered, in violation of A.R.S. §§13-3623(A)(1), 13-3601, 13-705, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 2 felony, Dangerous Crime Against Children, first degree.

**COUNT 9**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** intentionally and knowingly committed Child Abuse by, under circumstances likely to cause death or serious physical injury, causing physical injury to [REDACTED], or having the care or custody of such a child, causes or permits the person or health of such child to be placed in a situation where his physical health is endangered, in violation of A.R.S. §§13-3623(A)(1), 13-3601, 13-705, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 2 felony, Dangerous Crime Against Children, first degree.

**COUNT 10**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** intentionally and knowingly committed Child Abuse by, under circumstances likely to cause death or serious physical injury, causing physical injury to [REDACTED], or having the care or custody of such a child, causes or permits the person or health of such child to be placed in a situation where his physical health is endangered, in violation of A.R.S. §§13-3623(A)(1), 13-3601, 13-705, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 2 felony, Dangerous Crime Against Children, first degree, Dangerous Crime Against Children, first degree.

**COUNT 11**

On or about 12/25/2013, in or near Casa Grande, Arizona, **CONNIE VILLA** committed First Degree Murder by committing the crime of Child Abuse under 13-3623(A)(1), and in the course or furtherance or immediate flight from that offense, **CONNIE VILLA** caused the death of [REDACTED], in violation of A.R.S. §§13-1105(A)(2), 13-1101, 13-3601, 13-705, 13-610, 13-701, 13-702, 13-712, and 13-801, a class 1 felony, Dangerous Crime Against Children, first degree.
