When arrived at Clement Park he was eventually detained by JCSO and later debriefed. Just weeks prior to the CHS shootings began to notice that Harris was becoming more aggressive and was picking fights with other people. **b7C** was unaware of any Websites that Harris had. **b7D** After the shootings had recalled in retrospect that approximately one to two weeks prior to the shooting she had observed Harris and Klebold in the CHS cafeteria looking over a piece of paper. the paper was a diagram of the school cafeteria along with the location of the cameras.




